9/2012	(1)	This Act comes into operation on the day after the day on which it receives the Royal Assent.
10/2012	(1)	Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
	(2)	If a provision of this Act does not come into operation before 1 July 2012, it comes into operation on that day.
11/2012	(1)	Section 1, this section and section 5 come into operation on the day after the day on which this Act receives the Royal Assent.
	(2)	Subject to subsection (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.
	(3)	If a provision referred to in subsection (2) does not come into operation before 1 July 2012, it comes into operation on that day.
12/2012	(1)	Subject to subsection (2), this Act comes into operation on a day to be proclaimed.
	(2)	If this Act does not come into operation before 1 October 2012, it comes into operation on that date.
13/2012	(1)	This Act comes into operation on a day or days to be proclaimed.
