Road Safety Act 1986

EXEMPTION FOR THE RUNNING OF ASIA PACIFIC IRONMAN CHAMPIONSHIP MELBOURNE

1 Purpose

The purpose of this notice is to exempt competitors and organisers of Asia Pacific Ironman Championship event from certain provisions of the **Road Safety Act 1986** and the Road Safety Road Rules 2009 while they perform the activities necessary to safely compete in the event on Sunday 25 March 2012.

2 Background

Tri Events has applied under section 99B(4) of the **Road Safety Act 1986** for exemption from the certain provisions of the Road Safety Road Rules 2009 for the purposes of enabling Event organisers and competitors to safely stage the event. The event is scheduled to take place between 5.00 am and 11.59 pm on Sunday 25 March 2012.

3 Authorising provision

This notice is made under section 99B(4) of the **Road Safety Act 1986**. Section 99B(4) provides that the Minister may, on the application of a person proposing to conduct a non-road activity on a highway, by notice published in the Government Gazette declare that specified provisions of the **Road Safety Act 1986** and of the regulations made under that Act do not apply with respect to the non-road activity specified in the notice to be conducted on a highway or part of a highway specified in the notice during the period specified.

With respect to the above section of the Act, the authority to declare that specified provisions of the Act do not apply to a non-road activity by notice in the Government Gazette, has been delegated to the Executive Director Regional Services, VicRoads.

4 Commencement

This notice comes into operation at 12 am Sunday 25 March 2012.

5 Expiry

This notice expires at 11.59 pm Sunday 25 March 2012.

6 Declaration

I, Gary Liddle, Chief Executive, acting under section 99B(4) of the **Road Safety Act 1986** and on the application of Tri Events, declare that the provisions of the **Road Safety Act 1986** and the Road Safety Road Rules 2009 specified in Schedule 1 do not apply to the non-road activity specified in column 1 of Schedule 2 conducted on the highways specified in column 2 of Schedule 2 during the period specified in column 3 of Schedule 2, subject to the conditions set out in paragraph 7.

7 Conditions

This exemption is subject to the following conditions –

- (1) The owner of the land on which the non-road activity is to be conducted must have consented to that activity.
- (2) Except the provisions exempted by this notice and as set out in Schedule 1, all relevant safety requirements must be complied with including (without limitation) all provisions of the **Road Safety Act 1986**, the Road Safety Road Rules 2009, the **Road Management Act 2004** and the **Occupational Health and Safety Act 2004** and any regulations made under those Acts.
- (3) A copy of this notice must be produced on demand to any member of the police force or to any person who is an authorised officer under section 71 of the **Road Management Act 2004**.
- (4) Failure to comply with a condition specified in paragraph 7 does not invalidate the exemption given by this Notice.

SPECIAL

Schedule 1

Provisions of Road Safety Act 1986 and Road Safety Road Rules 2009 to which this exemption applies
Road Safety Act 1986 – section 68A – pedestrians and bicycle riders on a freeway. All Road Rules except for road rules 264 to 266 (inclusive) wearing of seatbelts by drivers and passengers and road rule 256 wearing of bicycle helmets.

Schedule 11 Clause 4

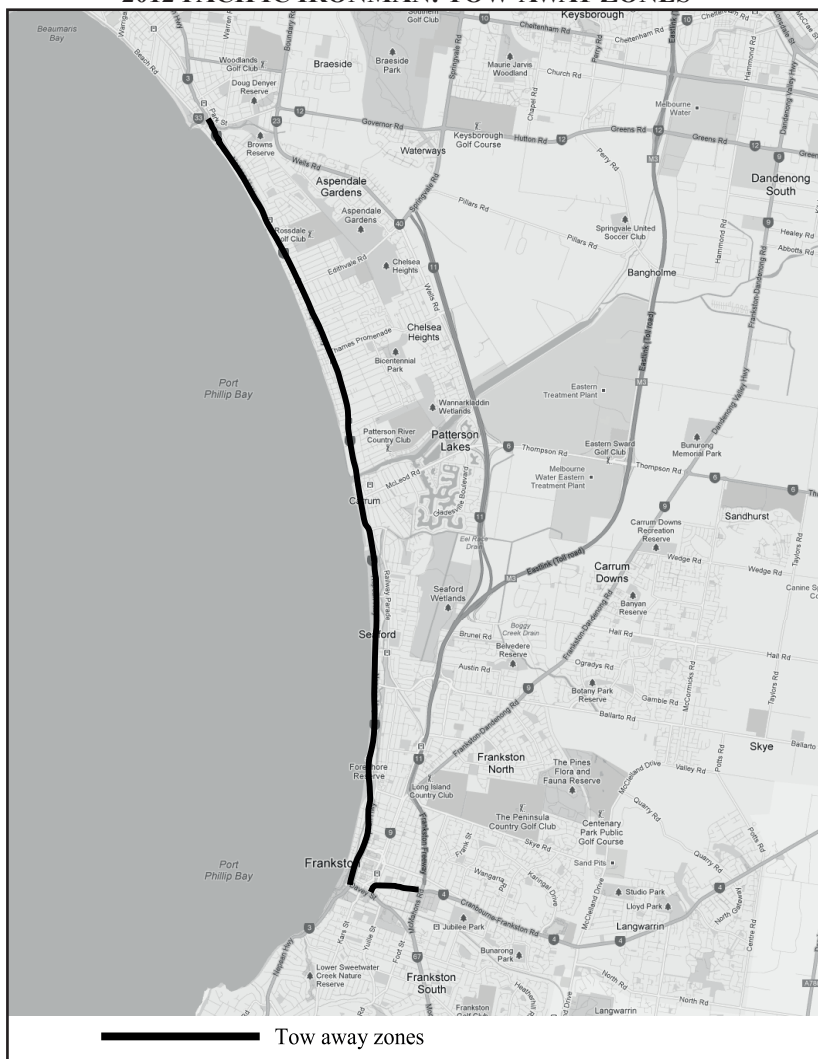
DESIGNATION OF TOW AWAY AREAS

Clause 4 of Schedule 11 of the **Local Government Act 1989** provides that a Council may move or impound any vehicle that is causing an unlawful obstruction, or that is unlawfully parked or left standing in an area designated by the Minister, (referred to in this instrument as a ‘tow-away area’), and may charge the owner of the vehicle a fee up to the amount of the fee set for the purposes of clause 3(1)(c).

For the purposes of that provision, I, Terry Mulder, Minister for Roads, designate the locations specified and shown on the plan under this text, to be a tow-away area.

This instrument takes effect at 12.00 am on Sunday 25 March 2012 and expires at 11.59 pm on Sunday 25 March 2012.
