**Marine Act 1988**

## SECTION 15 NOTICE

I, Peter Corcoran, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Dennis Hovenden, Chief Executive Officer, Swan Hill Rural City Council (Waterway Manager for Lake Boga), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. from 6.30 am on Saturday 24 March 2012 to 6.00 pm on Sunday 25 March 2012 bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels and bathers involved with the Ski Racing Victoria Point Score Race, is prohibited on all of the waters of Lake Boga;
2. vessels competing in the Ski Racing Victoria Point Score Race at Lake Boga are excluded from the requirements of Clauses 2(a), 2(c) and 3(b) of Notice No. 1 under section 15(2) of the **Marine Act 1988** for the duration of the event;
3. vessels competing in the Ski Racing Victoria Point Score Race at Lake Boga are exempt from the requirements of Regulation 228(3) of the Marine Regulations 2009, in respect to the requirement to carry a torch, bucket or anchor for the duration of the event; and
4. at the completion of the event or at a time determined by Swan Hill Rural City Council to enable the completion of the event, the waters will revert to the provisions of Schedule 74 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.
