## Marine Act 1988

### SECTION 15 NOTICE

I, Peter Corcoran, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Vincent Wright, Acting Regional Manager, Bays and Maritime Operations, Parks Victoria (Waterway Manager for the Yarra River upstream of the Designated Port of Port Phillip), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. For the days and times detailed in Table 1, the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels associated with the Australian Dragon Boat Championships, vessels owned and operated by Parks Victoria and vessels authorised by Parks Victoria, is prohibited on the waters of the Yarra River within the area detailed below in Table 2.
2. Vessels providing rescue services for the Australian Dragon Boat Championships are exempt from the 5 knot speed limit as detailed in Clause 1 of Schedule 3 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988** for the duration of the event, and from the requirement to operate a vessel at a speed not exceeding 5 knots within 50 meters of a person in the water, another vessel, the waters edge and fixed or floating structures, as detailed in clauses 2(a), 2(c) and 3 of Notice No. 1 under section 15(2) of the **Marine Act 1988** for the duration of the event.
3. Competitors vessels, vessels engaged in supervision, judging or marshalling for the Australian Dragon Boat Championships are exempt from the 5 knot speed limit as detailed in Clause 1 of Schedule 3 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988** for the duration of the event and from the requirement to operate a vessel at a speed not exceeding 5 knots within 50 meters of a person in the water, another vessel, the waters edge and fixed or floating structures, as detailed in clauses 2(a), 2(c) and 3 of Notice No. 1 under section 15(2) of the **Marine Act 1988** for the duration of the event.
4. Vessels competing in the Australian Dragon Boat Championships are exempt from the requirements of Regulation 231 and 235 of the Marine Regulations 2009, in respect to the carriage and wearing of a PFD.
5. As a condition for the above exemptions;
  - (i) each rescue vessel must be crewed by a person holding at a minimum a Level 2 First Aid qualification, and
  - (ii) a diver qualified in rescue and first aid will be on water at all times, and
  - (iii) Parks Victoria is required to enforce the safety conditions given in the event application and subsequent documentation.

(ii)	A line extending from a marker buoy located in approximate position 37° 49' 6.05215" S, 144° 56' 18.83898" E to a marker buoy in approximate position 37° 49' 9.03205" S, 144° 56' 19.72938" E;
(iii)	A line extending from a marker buoy located in approximate position 37° 49' 9.03205" S, 144° 56' 19.72938" E to a marker buoy in approximate position 37° 49' 6.79064" S, 144° 56' 31.61896" E;
(iv)	A line extending from a marker buoy located in approximate position 37° 49' 6.79064" S, 144° 56' 31.61896" E to a point on shore at position 37° 49' 7.46572" S, 144° 56' 33.30559" E.

6. At the completion of the event or at a time determined by Parks Victoria to enable the completion of the event, the waters will revert to the provisions of Schedule 3 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.

I, Peter Corcoran, the Director Maritime Safety (as delegate of the Director, Transport Safety) on the recommendation of Inspector Stephen Guilmartin, OIC – Water Police Squad/Search and Rescue Squad, Victoria Police, hereby give notice under section 15(2) of the **Marine Act 1988** that:

1. from the publication of this Notice till 5.00 pm Saturday 30 June 2012, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie) excluding those vessels involved with the Victorian Desalination Project, is prohibited on the waters of Bass Strait (in the vicinity of Powlett River South Gippsland) within the waters bounded by the Latitude and Longitude points detailed in Table 1.
