Pursuant to section 241(2) of the **Transport Integration Act 2010**, I fix 2 April 2012 as the relevant date for the purposes of an allocation statement dated on or around the same date as this notice made under section 243 of the **Transport Integration Act 2010** to transfer the following property, rights and liabilities of the Public Transport Ticketing Body (operating as the Transport Ticketing Authority) (PTTB) to the Public Transport Development Authority:

- (a) rights and liabilities associated with the employment by PTTB of, and the administration and management of the employment by PTTB of, the personnel considered necessary by PTTB to manage the ongoing operations of the myki ticketing system and related matters in parallel with and following the transition from a dual myki/metcard ticketing system to a sole myki ticketing system, which will also cover V/Line services to nominated regional centres and the local bus services within those regional centres and their surrounds; and
- (b) information technology assets used by the transferring personnel in the course of their employment, but not including fixed line telephone assets.
