**SECTION 15 NOTICE** 

I, Peter Corcoran, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Chris Hardman, Regional Manager, Parks Victoria (Waterway Manager for Albert Park Lake), hereby give notice under section 15(1) of the **Marine Act 1988** that Notice 584/2012 (as published in the Victoria Government Gazette S55, Wednesday 29 February 2012) is hereby revoked and that:

- 1. The operation of vessels (including anchoring, mooring or allowing a vessel to lie) is prohibited on the waters of Albert Park Lake for the dates and times specified in Table 1.
- 2. Parks Victoria vessels and vessels approved by Parks Victoria are excluded from the prohibition on the operation of vessels for the times detailed in Table 1.
- 3. Parks Victoria vessels and vessels approved by Parks Victoria are excluded from the provisions of Clause 1 (5 knot speed restriction) of Schedule 151 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988** for the times listed in Table 1.
- 4. Vessels involved with the Australian Grand Prix 'Lake Activity' water ski show are excluded from clauses 2(a), 2(c), 3(a), 3(b), 14, and 19(b) of Notice No. 1 under section 15(2) of the **Marine Act 1988** for the times listed in Table 1.
- 5. Skiers involved in the water ski trick ski events are exempt from the requirements of Regulation 234(1) of the Marine Regulations 1999 and Clause 19(d) of Notice No. 1 under section 15(2) of the **Marine Act 1988**, for the times listed in Table 1.
- 6. At the completion of events on any of the days detailed in Table 1 or at a time determined by Parks Victoria to enable the completion of events, the waters will revert to the provisions of Schedule 151 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.
