
SECTION 15 NOTICE

- I, Peter Corcoran, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Inspector Stephen Guilmartin, OIC Water Police Squad/Search and Rescue Squad Victoria Police, hereby give notice under section 15(2) of the **Marine Act 1988** that from the publication of this Notice until further notice:
- 1. the operation of vessels other than those vessels approved by Victoria Police is prohibited within 100 metres of any levee or levee wall within the area detailed in Table 1, and
- 2. all vessels operating within the area detailed in Table 1; are subject to:
 - (a) a 5 knot maximum speed limit, and
 - (b) required to operate in such a way as to create minimal or no wash.

Table 1:

The waters bounded by:

- (i) A line extending from a point 36° 03' 02"S, 145°11' 50" E to a point 36° 04' 02" S, 145°11' 50" E;
- (ii) A line extending from a point 36° 04′ 02" S, 145°11' 50" E to a point 36° 04′ 02" S, 145° 12′ 53" E;
- (iii) A line extending from a point 36° 04' 02" S, 145°12' 53" E to a point 36° 03' 02" S, 145° 12' 53" E:
- (iv) A line extending from a point 36° 03' 02", 145°12' 53" E to a point 36° 03' 02" S, 145° 11' 50" E.
