ORDER APPOINTING PERSONS OR BODIES TO BE WATERWAY MANAGERS IN RESPECT OF SPECIFIED STATE WATERS

I, Dr Denis Napthine, Minister for Ports make the following Orders.

Pursuant to section 3(3)(b) of the **Marine Act 1988** (Vic), I declare the person or body listed in Column 1 of the following table to be a waterway manager in respect of the State waters specified opposite the name of the waterway manager in column 2.

SECTION 15 NOTICE

I, Peter Corcoran, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Timothy Hungerford-Morgan, Harbour Master, Gippsland Ports (the Waterway Manager for Designated Port of Gippsland Lakes), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. From 6.00 am to 6.00 pm Saturday 14 April 2012, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels involved with the Paynesville Gold Cup powerboat racing event and vessels owned and operated by Gippsland Ports, are prohibited on the waters of Lake King in the vicinity of Fort King and the Northern entrance to MacMillan Strait as marked by yellow buoys.
2. Vessels competing in the Paynesville Gold Cup powerboat racing event at Lake King are excluded from the requirements to operate a vessel at a speed not exceeding 5 knots within 50 meters of another vessel, the waters edge and fixed or floating structures, as detailed clauses 2(c), 3(a) and 3(b) of Notice No. 1 under section 15(2) of the **Marine Act 1988** for the duration of the event.
3. At the completion of the event or at a time determined by Gippsland Ports to enable the completion of the event, the waters will revert to the provisions of Schedule 104 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.
