SECTION 15 NOTICE

I, Peter Corcoran, the Director, Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Dennis Hovenden, Chief Executive Officer, Swan Hill Rural City Council (the waterway manager for Lake Boga), hereby give notice under Section 15(1) of the **Marine Act 1988** that:

- 1. From 9.00 am Saturday 21 April 2012 till 5.00 pm Sunday 22 April, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels involved with the 'Splash In' amphibious aircraft event, are prohibited on the waters of Lake Boga. of Notice no. 1 under Section 15(2) of the **Marine Act 1988** for the duration of the event.
- 3. At the completion of the event, or at a time determined by Swan Hill Rural City Council to enable the completion of the event, the waters will revert to the provisions of Schedule 74 contained in Notice no. 1 under Section 15(2) of the **Marine Act 1988**.

SECTION 15 NOTICE

I, Peter Corcoran, the Director, Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of David Jackson, Manager Land & On Water, Goulburn Murray Water (Waterway Manager for Lake Eppalock), hereby give notice under Section 15(1) of the **Marine** Act 1988 that:

- 1. from 8.00 am to 6.00 pm Sunday 29 April 2012, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels associated with the Victorian Speed Boat Club (VSBC) Victorian Inboard Championships and vessels operated by Goulburn Murray Water, are prohibited on the waters of Lake Eppalock in the Derrinal Pool area in the vicinity of the VSBC leasehold as marked by buoys;
- 2. Vessels competing in the VSBC Victorian Inboard Championships event within the exclusion zone are excluded from the requirements to operate a vessel at a speed not exceeding 5 knots within 50 meters of another vessel, the waters edge and fixed or floating structures, as detailed in clauses 2(c), 3(a) and 3(b) of Notice no. 1 under Section 15(2) of the **Marine Act** 1988 for the duration of the event.
- 3. Vessels competing in the VSBC Victorian Inboard Championships event are excluded from the requirements of Schedule 49 of Notice no.1 under Section 15(2) of the **Marine Act 1988** when operating within the exclusion zone detailed above.

SPECIAL

4. At the completion of the event, or at a time determined by Goulburn Murray Water to enable the completion of the event, the waters will revert to the provisions of Schedule 49 contained in Notice no. 1 under Section 15(2) of the **Marine Act 1988**.
