ROAD DECLARATIONS AND DISCONTINUATIONS

ROAD DECLARATIONS

VicRoads, pursuant to sections 11 and 14 of the **Road Management Act 2004**, upon publication of this notice declares or revokes parts of the roads described in Schedule A and on the plans attached. The effects of these declarations or revocations on road names are described in Table 1.

ROAD DISCONTINUATIONS

VicRoads, pursuant to section 12 of the **Road Management Act 2004**, upon publication of this notice discontinues parts of the roads described in Schedule B and on the plans attached subject to the right, power and interest held by Powercor Australia Ltd over land parcels E-1, E-2, E-3, E-4 and E-5 described on the plans as provided for in section 207C of the **Local Government Act 1989** and approves the sale of the surplus land as provided in section 94 of the **Transport Integration Act 2010** and as delegated by the Minister for Roads under section 31 of the latter said Act.

SCHEDULE A

ARTERIAL ROAD

- a) Those parts of Gordon Street identified by hatching on the plan numbered GP20218 are declared as described in the legend in the said plan.
- b) That part of Western Highway identified by hatching on the plan numbered GP20218 is declared as described in the legend in the said plan.
- c) That part of Huntingdale Road identified by hatching on the plan numbered GP21213 is declared as described in the legend in the said plan.
- d) Those parts of Strzelecki Highway identified by cross hatching on the plan numbered GP21258A are revoked as described in the legend in the said plan.
- e) Those parts of Baxter-Tooradin Road identified by hatching on the plan numbered GP22020 are declared as described in the legend in the said plan.

MUNICIPAL ROAD

- f) Those parts of Smiths Lane identified by hatching on the plan numbered GP22021 are declared as described in the legend in the said plan.
- g) Those parts of Tyabb-Tooradin Road identified by hatching on the plan numbered GP22021 are declared as described in the legend in the said plan.
- h) Those parts of Leversha Road identified by cross hatching on the plans numbered GP22237, GP22238, GP22240 and GP22242 are revoked as described in the legend in the said plans.

SCHEDULE B

ARTERIAL ROAD

i) Those parts of Strzelecki Highway identified by cross hatching on the plan numbered GP21258A are discontinued as described in the legend in the said plan.

MUNICIPAL ROAD

j) Those parts of Leversha Road identified by cross hatching on the plans numbered GP22237, GP22238, GP22240 and GP22242 are discontinued as described in the legend in the said plans.

EFFECTS ON ROAD NAMES


- 1. Names in Column 2 are unaffected by this notice, unless otherwise stated.

- 3. Names in Column 2 may not apply to the whole length of the road and are for general information purposes only.


