28/2012	(1)	This Act comes into operation on a day or days to be proclaimed.		
29/2012	(1)	Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.		
	(2)	If a provision of this Act does not come into operation before 11 April 2013, it comes into operation on that day.		
30/2012	(1)	This Act comes into operation on the day after the day on which it receives the Royal Assent.
