Road Safety Act 1986

EXEMPTION FROM SECTION 65A(1) OF THE **ROAD SAFETY ACT 1986** FOR PERSONS PARTICIPATING IN THE AUSTRALIAN NATIONAL CIRCLE WORK CHAMPIONSHIPS AT THE PAKENHAM RACECOURSE

1. Purpose

The purpose of this notice is to exempt persons from section 65A(1) of the **Road Safety Act 1986** while participating in a Victorian heat of the Australian National Circle Work Championships at the Pakenham Racecourse.

2. Authorising provision

This notice is made under section 65A(3)(a) of the **Road Safety Act 1986**.

Section 65A(1) of the **Road Safety Act 1986** provides that a person must not drive a motor vehicle in a manner which causes the motor vehicle to undergo loss of traction by one or more of the motor vehicle's wheels. (Penalty: 5 penalty units)

Section 65A(3)(a) empowers the Minister to declare, by notice published in the Victoria Government Gazette, that the offence in section 65A(1) does not apply to persons while participating in a function or event specified in the declaration and conducted on land specified in the declaration.

3. Commencement

This notice comes into operation on the day on which it is published in the Victoria Government Gazette.

4. Expiry

This notice expires on 27 May 2012.

5. Declaration

For the purposes of section 65A(3)(a) of the **Road Safety Act 1986**, I, Terry Mulder MP, Minister for Roads, declare that section 65A(1) of the **Road Safety Act 1986** does not apply to a person while participating in a heat of the Australian National Circle Work Championships at the Pakenham Racecourse on 26 May 2012 or 27 May 2012, provided that all safety and other requirements, as determined by the event organiser, are complied with.
