



# Road Management Act 2004

# EXEMPTION FROM GIVING NOTICE OF THE PROPOSED DISCONTINUANCE OF PARTS OF WEST GATE FREEWAY FOR MONASH-CITYLINK-WEST GATE (M1) UPGRADE PROJECT PURPOSES

I, Terry Mulder, Minister for Roads, under sub-section 12(11)(b) of the **Road Management** Act 2004, exempt VicRoads from the requirements of sub-sections 12(4) to 12(10) of that Act for the proposed road discontinuance of parts of West Gate Freeway in South Wharf, at the location shown generally in the diagram below and more particularly as Parcels 301S, 301T, 301U and 302A on VicRoads Survey Plan SP22569, a copy of which may be requested from VicRoads. The road discontinuances are required for the purposes of the Monash-CityLink-West Gate (M1) Upgrade Project.

# ROAD DECLARATION




