- 21/2012 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
- (2) If a provision of this Act does not come into operation before 1 December 2012, it comes into operation on that day.
- 22/2012 (1) Subject to subsection (2), this Act comes into operation on a day to be proclaimed.
- (2) If this Act does not come into operation before 1 July 2012, it comes into operation on that day.
- 23/2012 (1) Part 1 comes into operation on the day on which this Act receives the Royal Assent.
- (2) Part 4 is taken to have come into operation on 6 February 2012.
- (3) Part 3 and Part 6 come into operation on the day after the day on which this Act receives the Royal Assent.
- (4) Subject to subsection (5), the remaining provisions of this Act come into operation on a day or days to be proclaimed.
- (5) If a provision of this Act does not come into operation before 30 June 2012, it comes into operation on that day.
- 24/2012 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
- (2) If a provision of this Act does not come into operation before 1 January 2013, it comes into operation on that day.
- 25/2012 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
- (2) If a provision of this Act does not come into operation before 31 December 2012, it comes into operation on that day.
