ROAD DECLARATIONS AND DISCONTINUATION

ROAD DECLARATIONS

VicRoads, pursuant to sections 11 and 14 of the **Road Management Act 2004**, upon publication of this notice revokes, declares and renames the roads described in Schedule A and on the plans attached. The effects of these publications on road names are described in Table 1.

ROAD DISCONTINUATION

VicRoads, pursuant to section 12 of the **Road Management Act 2004**, upon publication of this notice discontinues parts of the road described in Schedule B and on the plan attached and approves the sale of the surplus land as provided in section 94 of the **Transport Integration Act 2010** and as delegated by the Minister for Roads under section 31 of the latter said Act.

SCHEDULE A

ARTERIAL ROAD

- a) Those parts of Heidelberg Road identified by hatching on the plan numbered GP21655 are revoked as described in the legend in the said plan.
- b) That part of Loch Valley Road identified by heavy broken line on the plan numbered GP285AR is revoked as described in the legend in the said plan.
- c) Those parts of Boolarra South–Mirboo North Road identified by hatching on the plan numbered GP287AR are declared as described in the legend in the said plan.
- d) That part of Tramway Road identified by heavy solid line on the plan numbered GP286AR is renamed as described in the legend in the said plan.

MUNICIPAL ROAD

- e) That part of Loch Valley Road identified by heavy solid line on the plan numbered GP45MU is declared as described in the legend in the said plan.

SCHEDULE B

- f) Those parts of Heidelberg Road identified by hatching on the plan numbered GP21655 are discontinued as described in the legend in the said plan.
