	(2)	Section 3(1) and (2) and Part 4 come into operation on 1 July 2012.		
	(3)	Subject to subsection (4), sections 4 to 7 and 15 to 20 come into operation on a day or days to be proclaimed.		
	(4)	If a provision referred to in subsection (3) does not come into operation before 1 September 2012, it comes into operation on that day.		
33/2012	(1)	This Act comes into operation on 1 July 2012.		
34/2012	(1)	This Act comes into operation on 1 July 2012.		
35/2012 (1) This Part comes into operation on the day of Assent.		This Part comes into operation on the day on which this Act receives the Royal Assent.		
	(2)	Sections 11, 12, 13, 14 and 17 are taken to have come into operation on 16 May 2012.		
	(3)	Parts 2, 3, 4 and 7 and the remaining provisions of Part 6 come into operation on the day after the day on which this Act receives the Royal Assent.		
	(4)	Subject to subsection (5), Part 5 comes into operation on a day to be proclaimed.		
	(5)	If Part 5 does not come into operation before 31 July 2013, it comes into operation on that day.
