STATE OWNED ENTERPRISE FOR IRRIGATION MODERNISATION IN NORTHERN VICTORIA ORDER 2012

Order in Council

The Lieutenant-Governor, as the Governor's Deputy, with the advice of the Executive Council, under –

- (a) section 7 of the **State Owned Enterprises Act 1992** (the Act), declares the State Owned Enterprise for Irrigation Modernisation in Northern Victoria, to be a reorganising body; and
- (b) section 8A of the Act, on the recommendation of the Treasurer after consultation with the relevant Minister, the Minister for Water, alters or varies the functions of that reorganising body, specified in clause 5 of the State Owned Enterprises (State Body – State Owned Enterprise for Irrigation Modernisation in Northern Victoria) Order 2007, published in the Government Gazette at pages 3199–3203, on 20 December 2007, to delete clause 5 and to substitute the following clause –

‘5. Functions

The functions of the State Owned Enterprise for Irrigation Modernisation in Northern Victoria are to –

- (a) plan, design and deliver the Program; and
- (b) in cooperation with Goulburn–Murray Rural Water Corporation, to facilitate and assist in the transfer of all of its property, liabilities, staff and activities to Goulburn–Murray Rural Water Corporation by 30 June 2012 or as soon as possible thereafter consistent with the priorities of the Victorian Government.’

This Order comes into effect on the date on which it is published in the Government Gazette.
