SECTION 15 NOTICE

I, Peter Corcoran, the Director Maritime Safety (as delegate of the Director, Transport Safety), on the recommendation of Vincent Wright, Acting Regional Manager, Bays and Maritime Operations, Parks Victoria (Waterway Manager for the Yarra River upstream of the Designated Port of Port Phillip), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. For the times and dates detailed below in Table 1, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels involved with the City of Melbourne Winter Festival fireworks displays and vessels owned and operated by Parks Victoria, are prohibited on the waters of the Victoria Harbour within the area detailed below in Table 2.

2. At the completion of the event or at a time determined by Parks Victoria to enable the completion of the event, the waters will revert to the provisions of Schedule 3 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.

(Waterway Manager for The Local Port of Corner Inlet and Port Albert), hereby give notice under section 15(1) of the **Marine Act 1988** that from the publication of this notice and until further notice, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels engaged in works and approved by Gippsland Ports Committee of Management Inc., is prohibited within 10 metres of the Shipping Pier (Long Jetty) at Port Welshpool.
