Accident Towing Services Act 2007

DETERMINATION OF FEES

1. Purpose

The purpose of this notice is to determine fees for applications under the Accident Towing Services Act 2007.

2. Authorising Provision

This notice is made under section 213 of the Accident Towing Services Act 2007. Section 213(1) provides that VicRoads may determine fees for applications under that Act. Section 213(4) provides that fees determined by VicRoads under subsection (1) must be published in the Government Gazette.

3. Commencement

The determination in this notice comes into operation on 1 July 2012.

4. Revocation

The notice published in Government Gazette No. S 250 on Monday 1 August 2011 entitled 'Determination of Fees' is revoked.

5. Determination

I, Gary Liddle, Chief Executive of VicRoads, determine the fees set out in column 2 of the table below in respect of the corresponding applications in column 1 of the table.

Vary the hours of operation for a specified depot	\$175.20
Substitute the tow truck specified in licence for another tow truck	\$67.00
Transfer of a tow truck licence to another person	\$175.20
Temporary permits	\$22.50
Towing operator accreditation	\$67.00
Towing depot manager accreditation	\$67.00
Replacement certificate of accreditation operator and depot manager	\$22.50
Tow Truck driver accreditation	\$67.00
Replacement certificate of accreditation (tow truck driver)	\$22.50
Tow Truck Trainee Permit	\$22.50
