- 38/2012 (1) This Act comes into operation on 1 July 2012.
39/2012 (1) This Part and Part 7 come into operation on the day on which this Act receives the Royal Assent.
 (2) Section 62(5) is taken to have come into operation on 1 July 2007.
 (3) Subject to subsection (4), the remaining provisions of this Act come into operation on a day or days to be proclaimed.
 (4) If a provision of this Act referred to in subsection (3) (except section 50) does not come into operation before 1 January 2013, it comes into operation on that day.

SPECIAL

- 40/2012 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
- (2) If a provision of this Act does not come into operation before 22 May 2013, it comes into operation on that day.
- 41/2012 (1) This Act comes into operation on the day after the day on which this Act receives the Royal Assent.
- 42/2012 (1) This Act (other than Division 3 of Part 2 and Part 3) comes into operation on the day after the day on which it receives the Royal Assent.
- (2) Division 3 of Part 2 and Part 3 come into operation on 1 July 2012.
- 43/2012 (1) Subject to subsection (2), this Act comes into operation on the day after the day on which it receives the Royal Assent.
- (2) The following items in the Schedule are taken to have come into operation on the following dates –
- (a) item 5 on 2 November 2011;
- (b) item 6 on 31 December 2011;
- (c) item 15 on 2 November 2011;
- (d) item 17.1 on 17 March 2010;
- (e) item 27 on 19 February 2012;
- (f) item 28 on 20 April 2010;
- (g) item 43 on 19 October 2011;
- (h) item 45.1 on 29 June 2011;
- (i) item 47.1 on 15 January 2012;
- (j) item 47.3 on 15 January 2012;
- (k) item 47.4 on 15 January 2012;
- (l) item 47.5 on 15 January 2012;
- (m) item 55 on 14 December 2011.
- 44/2012 (1) This Act comes into operation on a day or days to be proclaimed, not being a day earlier than the day on which the Convention providing a Uniform Law on the Form of an International Will 1973 enters into force in respect of Australia.
