MINISTERIAL ORDER NO. 588

Revocation of Orders declaring Industry Training Boards

The Minister for Higher Education and Skills makes the following Order:

Title

1. This Order may be cited as Ministerial Order No. 588.

Purpose

2. The purpose of this Order is to revoke Orders in Council that declare industry training boards for the purposes of the **Education and Training Reform Act 2006**.

Background

3. Under section 3.1.27(1)(b) of the **Education and Training Reform Act 2006** (the ETR Act), the Minister may by Order published in the Government Gazette declare any association incorporated under the **Associations Incorporation Act 1981** or any company within the meaning of the Corporations Act that is taken to be registered in Victoria to be an industry training board in respect of the industry specified in the Order.
4. Prior to the repeal of the former **Vocational and Education Training Act 1990** (the VET Act), section 38 of that Act conferred a similar power on the Governor in Council to declare industry training boards.
5. A number of industry training boards were declared by Orders in Council under section 38 of the VET Act prior to that Act's repeal.
6. Under clause 1.12(2) of Schedule 8 to the ETR Act, an industry training board that had been declared by the Governor in Council under section 38 of the VET Act (prior to that Act's repeal) is deemed to be an industry training board declared by the Minister under and subject to the ETR Act.
7. Consequently, the industry training boards declared under the VET Act continue in operation under the provisions of the ETR Act, as if declared under the latter.

Authorising provision

8. This Ministerial Order is made under section 3.1.29(1) of the **Education and Training Reform Act 2006**.

Date of Effect

9. This Order takes effect on 1 July 2012.

Revocation of declaration of industry training boards

10. The Orders in Council listed in the Schedule to this Order are revoked.
