## Plant Biosecurity Act 2010

### NOTICE OF FEES AND CHARGES

I, Peter Walsh, Minister for Agriculture and Food Security, under section 55 of the **Plant Biosecurity Act 2010**, fix fees and charges at the rates described in the table below.

The Notice made under section 46 of the **Plant Health and Plant Products Act 1995**, and published in Government Gazette S95 on 20 June 2000 is revoked.

This Notice comes into operation on 1 July 2012.

1. the amount of a fee fixed under this notice is calculated by multiplying the number of the fee units by the value of a fee unit from time to time under section 5 of the **Monetary Units Act 2004** and, if the calculated amount is not a multiple of 5 cents, by rounding down to the nearest multiple of 5 cents.
2. the value of the calculated fee or charge is a GST exclusive amount.
