SECTION 15 NOTICE

- I, Peter Corcoran, the Director of Maritime Safety, (as delegate of the Director, Transport Safety on the recommendation of Michael Vanderzee, Chief Executive Officer, Winton Wetlands Committee of Management Inc. (the Waterway Manager for Winton Wetlands), hereby give notice under subsection 15(1) of the **Marine Act 1988**, that from the date of publication of this Notice in the Victoria Government Gazette till 20 June 2013:
- 1. the rules regulating the operation of vessels on the waters of Winton Wetlands set out in Schedule 87 of Notice No.1 under section 15(2) of the **Marine Act 1988** are hereby revoked; and
- replaced by the following rules regulating the operation of vessels on the waters of Winton Wetlands.

SCHEDULE 87 WATERS – WINTON WETLANDS

Waterway Manager – Winton Wetlands Committee of Management Inc.

- 87.1 Five (5) knot speed restriction for the purposes of Clause 7

 The whole of the waters of the Winton Wetlands are subject to a speed restriction of 5 knots.
- 87.2 Prohibition on Vessels with Engines for the purposes of Clause 10
 The whole of the waters of Winton Wetlands are prohibited to vessels with engines used for propulsion.
