## **Gambling Regulation Act 2003**

ORDER UNDER SECTION 3.4A.5(3A)

I, Hon Michael O'Brien, MP, Minister for Gaming in the State of Victoria, in relation to the regions in the State of Victoria determined under section 3.2.4(1) of the **Gambling Regulation Act 2003** (the Act) on 16 October 2009 and published in the Government Gazette on 20 October 2009, specify under section 3.4A.5(3A) of the Act that the maximum permissible number of gaming machine entitlements under which gaming may be conducted in the regions should be determined by the Victorian Commission for Gambling and Liquor Regulation using the following criteria:

Region 1 (the area covered by the local government area of the City of Ballarat as at 12 October 2006): 9.00 gaming machine entitlements per thousand persons aged 18 years and above in that region.

Region 2 (the area covered by that part of postcode 3081 included in the local government area of the City of Banyule as at 12 October 2006): 2.86 gaming machine entitlements per thousand persons aged 18 years and above in that region.

Region 3 (the area covered by the local government area of the Shire of Bass Coast as at 12 October 2006): 8.69 gaming machine entitlements per thousand persons aged 18 years and above in that region.

Region 4 (the area covered by that part of postcodes 3012, 3020, 3021, 3022, 3023 and 3038 included in the local government area of the City of Brimbank as at 12 October 2006): 7.56 gaming machine entitlements per thousand persons aged 18 years and above in that region.

Region 5 (the area covered by:

- (i) that part of postcodes 3177, 3803, 3975 and 3976 included in the local government area of the City of Casey as at 12 October 2006; and
- (ii) that part of postcode 3977 located north of Browns Road included in the local government area of the City of Casey as at 12 October 2006): 7.87 gaming machine entitlements per thousand persons aged 18 years and above in that region.

Region 6 (the area covered by the local government area of the City of Greater Dandenong as at 12 October 2006): 9.24 gaming machine entitlements per thousand persons aged 18 years and above in that region.

Region 7 (the area covered by the local government area of the City of Darebin as at 12 October 2006): 8.59 gaming machine entitlements per thousand persons aged 18 years and above in that region.

Region 8 (the area covered by the local government areas of the City of Greater Geelong and the Borough of Queenscliffe as at 12 October 2006): 8.20 gaming machine entitlements per thousand persons aged 18 years and above in that region.

Region 9 (the area covered by the local government area of the City of Greater Shepparton as at 12 October 2006): 6.99 gaming machine entitlements per thousand persons aged 18 years and above in that region.

Region 10 (the area covered by the local government area of the City of Hobsons Bay as at 12 October 2006): 8.46 gaming machine entitlements per thousand persons aged 18 years and above in that region.

Region 11 (the area covered by that part of postcodes 3043, 3047, 3048, 3060 and 3061 included in the local government area of the City of Hume as at 12 October 2006): 9.81 gaming machine entitlements per thousand persons aged 18 years and above in that region.

Region 12 (the area covered by the local government area of the City of Latrobe as at 12 October 2006): 8.99 gaming machine entitlements per thousand persons aged 18 years and above in that region.

Region 13 (the area covered by the local government area of the City of Maribyrnong as at 12 October 2006): 8.66 gaming machine entitlements per thousand persons aged 18 years and above in that region.

Region 14 (the area covered by that part of postcodes 3031, 3051 and 3053 included in the local government area of the City of Melbourne as at 12 October 2006): 6.39 gaming machine entitlements per thousand persons aged 18 years and above in that region.

Region 15 (the area covered by that part of postcodes 3147, 3148, 3166, 3167, 3168 and 3170 included in the local government area of the City of Monash as at 12 October 2006): 9.43 gaming machine entitlements per thousand persons aged 18 years and above in that region.

Region 16 (the area covered by the local government area of the City of Moonee Valley as at 12 October 2006): 8.22 gaming machine entitlements per thousand persons aged 18 years and above in that region.

Region 17 (the area covered by that part of postcodes 3055, 3056, 3057, 3058 and 3060 included in the local government area of the City of Moreland as at 12 October 2006): 8.47 gaming machine entitlements per thousand persons aged 18 years and above in that region.

Region 18 (the area covered by the local government area of the City of Warrnambool as at 12 October 2006): 9.11 gaming machine entitlements per thousand persons aged 18 years and above in that region.

Region 19 (the area covered by that part of postcodes 3074, 3075, 3076, 3082 and 3083 included in the local government area of the City of Whittlesea as at 12 October 2006): 6.73 gaming machine entitlements per thousand persons aged 18 years and above in that region.

Region 20 (the area covered by the local government area of the Shire of Yarra Ranges as at 16 October 2009 that is included in the Melbourne Statistical Division as at 16 October 2009): 9.62 gaming machine entitlements per thousand persons aged 18 years and above in that region.

This order takes effect on 16 August 2012.
