Water Act 1989

NOTICE OF PROPOSAL TO ISSUE MODEL BY-LAW; RECREATIONAL AREAS

I, Peter Walsh MLA, Minister for Water, in accordance with section 287Y of the Water Act 1989 (the Act), hereby give notice that I propose to issue a model by-law for the management of recreational areas managed and controlled by Victoria's water Authorities.

The purpose of the proposed model by-law is to prescribe laws for the management, protection and use of the lands, waterways and works under the Authority's management and control in a recreational area and to provide for a consistent approach to how these recreational areas are managed.

The model by-law provides a clear framework for how certain activities may be undertaken by visitors to these areas, thereby facilitating the effective and efficient management of the areas. Importantly, the model by-law provides for the protection of visitors, Authority staff, the environment, the water supply and any works under the management and control of an Authority.

An Authority may adopt the model by-law where it determines it needs it to regulate the recreational areas under its management or control.
