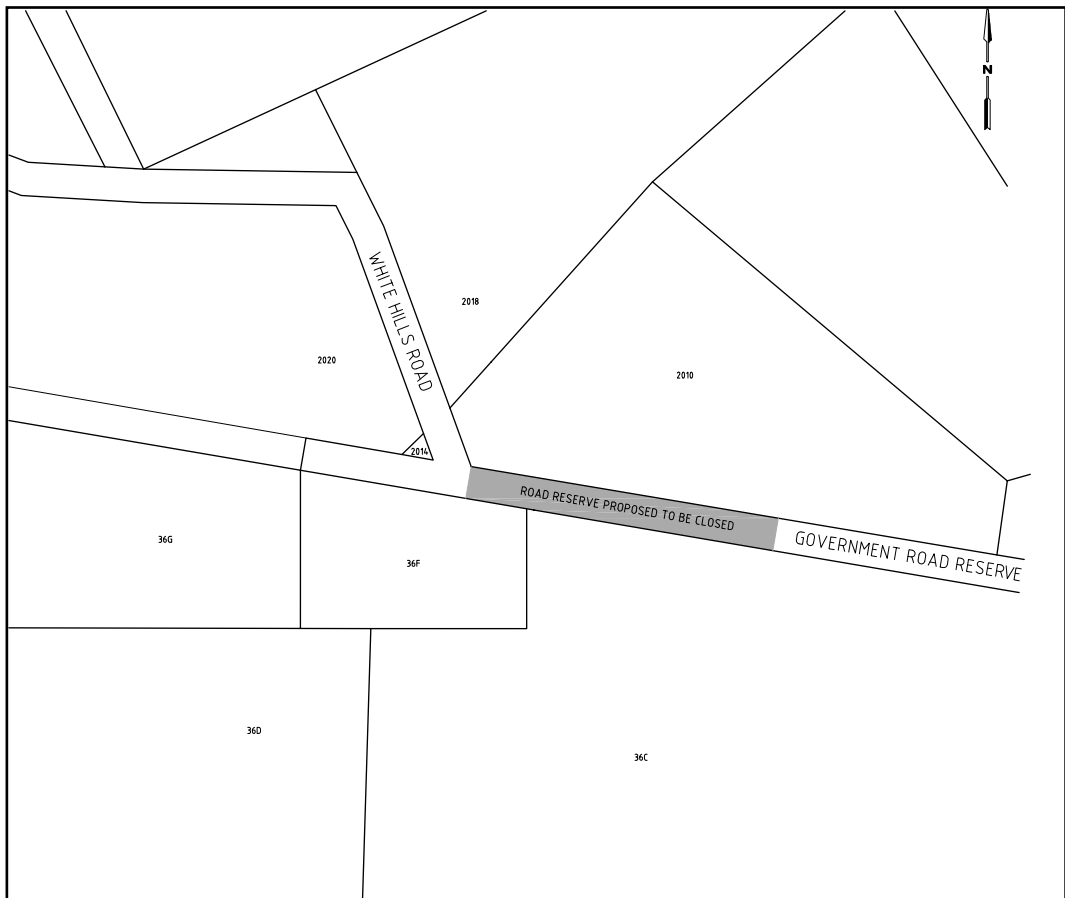

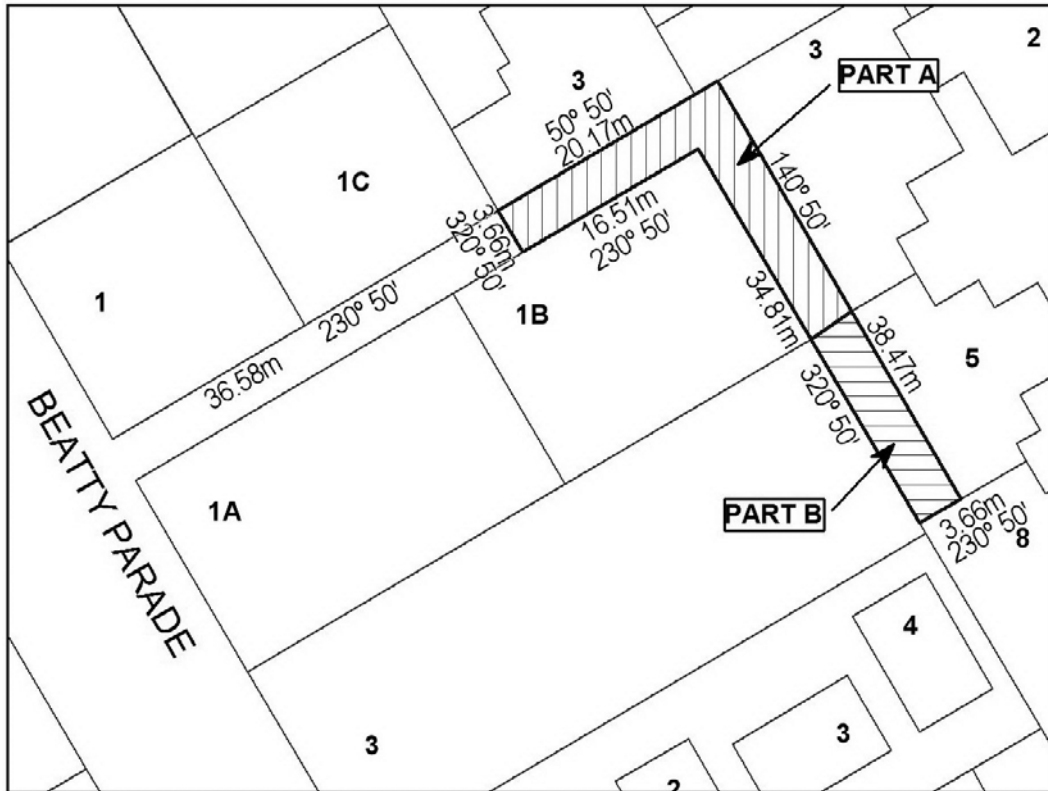
Discontinuance and Sale of Lane

Pursuant to section 206 and schedule 10, clause 3 of the **Local Government Act 1989**, the Mornington Peninsula Shire Council has formed the opinion that the lane adjacent to No. 1B and No. 3 Beatty Parade, Mornington, as shown hatched on the plan below, is not reasonably required as a road for public use.

The East Gippsland Shire Council has prepared Amendment C89 to the East Gippsland Planning Scheme.

In accordance with section 8A(3) of the **Planning and Environment Act 1987**, the Minister for Planning authorised the East Gippsland Shire Council as planning authority to prepare the Amendment.

The land affected by the Amendment is land within the Land Subject to Inundation Overlay, land at the Paynesville Canals and the Lindenow Escarpment.

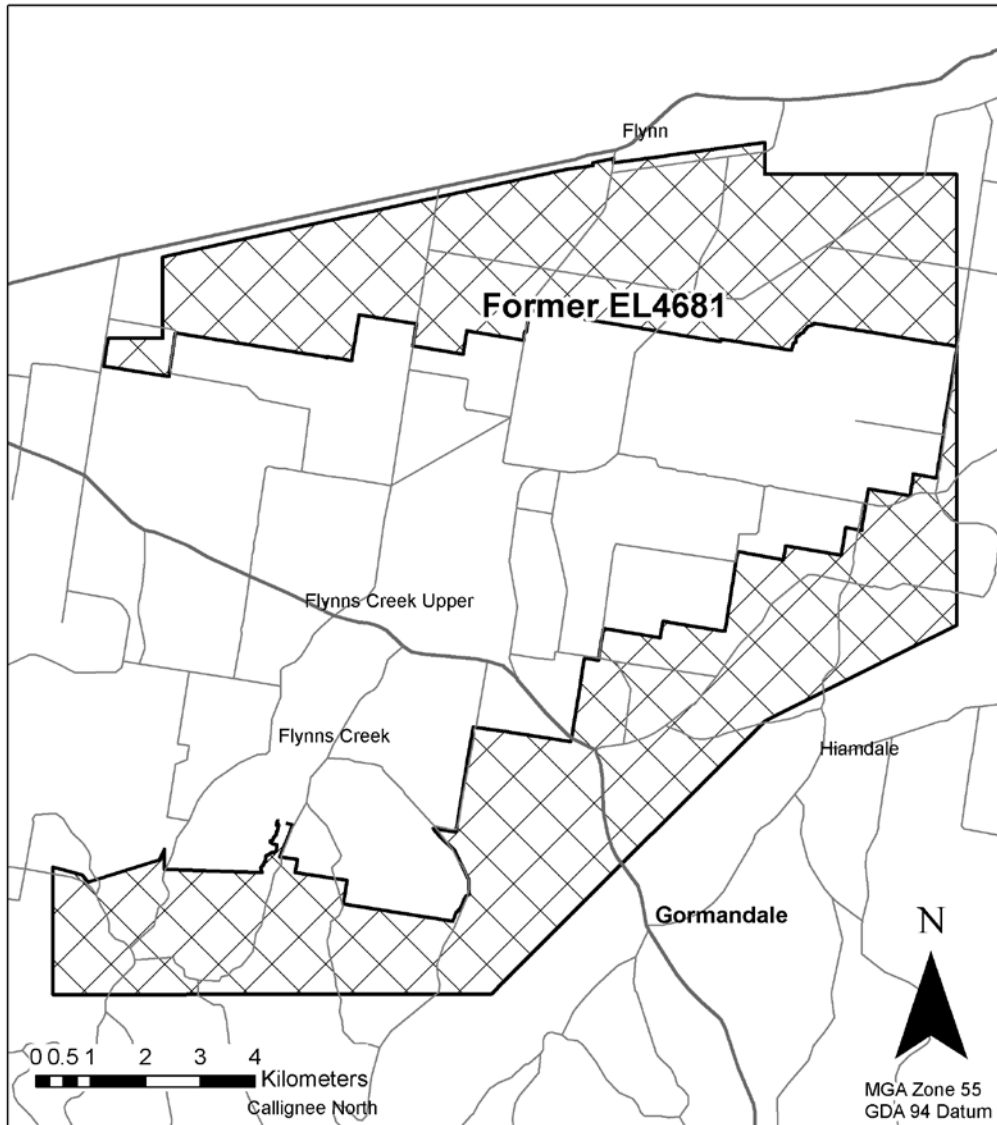

**Dangerous Goods (Storage and Handling) Regulations 2012**

Notice is given that, in accordance with section 11 of the **Subordinate Legislation Act 1994**, a Regulatory Impact Statement (RIS) has been prepared in relation to the proposed Dangerous Goods (Storage and Handling) Regulations 2012 (proposed regulations).

Copies of the RIS and the proposed regulations are now available for public review and comment. Closing date for submissions is 5.00 pm Thursday 11 October 2012.

The proposed regulations will replace the Dangerous Goods (Storage and Handling) Interim Regulations 2011 which are due to expire on 1 December 2012.

The main objective of the proposed regulations is to provide for the safe storage and handling of dangerous goods, including chemicals, petrol, LP gas and highly corrosive substances. These goods present significant risks to the community and the environment, and the proposed regulations will provide continuity in the safe storage and handling of these goods in Victoria.

The RIS discusses possible alternatives to the proposed regulations and concludes that the proposed regulations are the best means of achieving the stated objectives.

The RIS considers the costs and benefits of the proposed regulations and concludes that adoption of the proposed regulations will yield net benefits over the next 10 years.

The licensee must obtain and maintain insurance against expenses or liabilities or specified things arising in connection with, or as a result of, the carrying out of a pipeline operation, or the doing of any other thing, under the licence, including the expenses of complying with directions with respect to the clean-up or other remedying of the effects of the escape of petroleum, or any other liquid or gaseous substance, from the pipeline.
