- 48/2012      (1) This Act, except section 10, comes into operation on the day after the day on which it receives the Royal Assent.  
                  (2) Subject to subsection (3), section 10 comes into operation on a day to be proclaimed.  
                  (3) If section 10 does not come into operation before 1 November 2012, it comes into operation on that day.
- 49/2012      (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.  
                  (2) If a provision of this Act does not come into operation before 31 January 2013, it comes into operation on that day.
- 50/2012      (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.  
                  (2) If a provision of this Act does not come into operation before 1 April 2013, it comes into operation on that day.
