AMENDMENT OF DETERMINATION OF FIREWOOD COLLECTION AREAS

I, Helen Vaughan, Land and Fire Regional Manager South West, Department of Sustainability and Environment, as delegate of the Secretary to the Department of Sustainability and Environment, under section 57U of the **Forests Act 1958**, amend the determination made under section 57U of the **Forests Act 1958** on 29 August 2012 and published in the Government Gazette No. S 295 on 30 August 2012 by:

- (a) *substituting* '6/9/2012' for '30/11/2012' in column 6 of items 58, 64, 67, 76, 77, 80 and 82 in the table in the determination;
- (b) *substituting* '6/9/2012' for '30/06/2015' in column 6 of items 89 and 96; and
- (c) *substituting* '6/9/2012' for '30/11/2015' in column 6 of item 92.

This amendment takes effect on the date on which it is published in the Government Gazette.

DETERMINATION OF FIREWOOD COLLECTION AREAS

I, Helen Vaughan, Land and Fire Regional Manager South West, Department of Sustainability and Environment, make the following determination under section 57U of the **Forests Act 1958**.

Definitions

In this determination and with reference to a numbered item in the table in the determination:

- (a) *closing date*, being the date of revocation of the determination of a firewood collection area, means the date specified in column 6 of the item;
- (b) *opening date*, being the date on which the determination of a firewood collection area comes into operation, means the date specified in column 5 of the item or, if no date is specified, the date on which this determination is published in the Government Gazette.

Determination

Each area of State forest shown hatched on a plan lodged in the Central Plan Office of the Department of Sustainability and Environment, the number of which is shown in column 1 of an item in the table in this determination, is a firewood collection area for the purposes of section 57U of the **Forests Act 1958**, effective from the opening date for that area until the closing date for that area (inclusive).
