Project Development and Construction Management Act 1994

NOMINATION ORDER

Order in Council

The Governor in Council under section 6 of the **Project Development and Construction Management Act 1994** (“the Act”) declares the following development to be a project to which the Act applies:

- the Port Capacity Project (“Nominated Project”) which includes:
 - (a) the development of additional container capacity for Victoria via the development of Webb Dock East as a new international container terminal;
 - (b) infrastructure upgrades at Swanson Dock to increase the capacity of existing container terminals; and
 - (c) the development of Webb Dock West to accommodate Victoria’s roll-on, roll-off import and export automotive trade, including displaced trade from Webb Dock East,

AND in accordance with section 7 of the Act, specifies that:

- the Minister for Ports is the Minister who is to be responsible for the Nominated Project; and
- the Port of Melbourne Corporation, being a body corporate established under section 10 of the **Port Management Act 1995** (as in force immediately before the commencement of section 141B of the **Transport Integration Act 2010** (“the TIA”)) and continued under section 141B of the TIA, is to be the facilitating agency for the Nominated Project.

APPLICATION ORDER

Order in Council

The Governor in Council under section 8 of the **Project Development and Construction Management Act 1994** (“the Act”) declares in respect of the Port Capacity Project, a nominated project under section 6 of the Act, (“Nominated Project”) that:

- a) the following provisions of Part 3 of the Act apply in relation to the Nominated Project: sections 14, 16, 17, 18, 18A, 19, 20, 20A, 20B, 20C, 20D, 20E, 20F, 20G, 20H, 20I, 20J, 22(1)(a), 22(3), 22(4), 22(5), 22(6), 22(7), 22(8), 23, 24, 25 and 26;
- b) the following provisions of Part 3 of the Act apply to the Port of Melbourne Corporation, being a body corporate established under section 10 of the **Port Management Act 1995** (as in force immediately before the commencement of section 141B of the **Transport Integration Act 2010** (“the TIA”)) and continued under section 141B of the TIA, which is the facilitating agency for the Nominated Project: sections 14, 16, 17, 19, 20, 22(1)(a), 22(3), 22(4), 22(5), 22(6), 22(7), 22(8), 23, 24 and 25; and

SPECIAL

- c) the following provisions of Part 3 of the Act apply in relation to the responsible Minister for the Nominated Project: sections 19, 20, 22, 23 and 24.
