- Mrs Kumar to consult with a registered psychologist of her choice and at her own expense on a two-monthly basis for a period of twelve months to address the following matters in counselling:
 - a. The underlying issues that contributed to the teacher's misconduct
 - b. How to respond to personal stressors and the development of strategies to respond to stressful situations
 - c. Separating the 'personal' from the 'professional'.

- Mrs Kumar to provide the psychologist with a copy of this decision.
- The psychologist to provide two reports to the Institute at six-monthly intervals for a period of twelve months commenting on her progress. These reports should indicate the dates Mrs Kumar attended for consultations.
- Mrs Kumar to be mentored by Ms Jessica Reay on a two-monthly basis for a period of twelve months, at her own expense, to focus on the development of:
 - a. Building student engagement strategies
 - b. Communication within the classroom
 - c. An understanding of the Institute's Code of Conduct and Code of Ethics and their practical application.
- Ms Reay to provide a report to the Institute at six-monthly intervals for a period of twelve months on Mrs Kumar's progress in the nominated areas.
- Mrs Kumar to provide the Institute with a written explanation indicating a clear and comprehensive understanding of the conduct and behaviour of a teacher as outlined in the Victorian Institute's Code of Conduct and Code of Ethics by 31 December 2013 (but not before 30 September 2013).
