



PERMANENT WATER SAVING RULES

Coliban System (Northern) Raywood and Sebastian

Fountains and water features

Rule: Water cannot be used in a fountain or a water feature unless the fountain or water feature recirculates the water.

Cleaning of hard surfaces

Rule: Water cannot be used to clean hard surfaces (including, driveways, paths, concrete, tiles, timber decking) except:

- where cleaning is required as a result of an accident, fire, health hazard, safety hazard or other emergency; or
- if staining to the surface has developed and then only once a season; or
- in the course of construction or renovation, and then only by means of:
- a high pressure water cleaning device;
- or if such a device is not available, a handheld hose or a bucket.

The permanent water saving rules do not apply to the use of:

- recycled or reclaimed water;
- greywater;
- stormwater; or
- rainwater collected in a storage tank provided it is not supplemented by water supplied by Coliban Water or another water corporation, as defined in the Permanent Water Saving Plan.



 - d. Ms Pham's understanding of how her behaviour has breached the Victorian Teaching Profession Code of Ethics and Code of Conduct and in particular her legal obligations as a teacher and the conduct and behaviour required of a teacher.
 - e. What strategies Ms Pham could implement to ensure she does not repeat the offence. This report is to be submitted no later than two weeks after 30 June 2013.
- At the conclusion of the counselling sessions on 30 June 2013 Ms Pham is to provide a report to the Panel which comments, in her own words, on the following:
 - a. Ms Pham's acceptance and understanding of her guilt for the offence.
 - b. A detailed explanation of the circumstances of the offence.
 - c. How her behaviour has breached the Victorian Teaching Profession Code of Ethics and Code of Conduct and in particular her legal obligations as a teacher and the conduct and behaviour required of a teacher.
 - d. What strategies she will implement to ensure she does not repeat the offence.
