#### **Road Safety Act 1986**

#### ORDER UNDER SECTION 98 OF THE **ROAD SAFETY ACT 1986** EXTENDING PROVISIONS TO THE PARK AND RIDE FACILITIES AT CERTAIN RAILWAY STATION CAR PARKS

I, Bruce Gidley, Chief Operating Officer of VicRoads and delegate of the Minister for Roads, by this Order made under section 98 of the **Road Safety Act 1986** ('the Act') extend the application of:

- (a) sections 59, 64, 65, 65A, 76, 77, 86-90 and 100 of the Act;
- (b) the Road Safety Road Rules 2009; and
- (c) Parts 8 and 9 of, and Schedules 6 and 7 to, the Road Safety (General) Regulations 2009 -


to the off-street parking facilities and parking access roads located at the following railway stations, particulars of which are shown hatched on the attached plans:


- Beaconsfield railway station

- Thomastown railway station.


