ENERGY SAFE VICTORIA

Prohibition of Supply of Electrical Equipment

I, Paul Fearon, the Director of Energy Safety, under section 63(1) of the **Electricity Safety Act 1998** prohibit the supply of the electrical equipment specified in this notice effective 12 October 2013.

Prohibited Electrical Equipment

All Infinity branded PVC electrical cable or cables imported, supplied or distributed by Infinity Cable Co. Pty Ltd. This includes, but is not limited to:

- (1) all sizes, configurations and models of 'Polymeric Insulated Electrical Cable' which is PVC sheathed and insulated, flat and flexible and is designed for use in low voltage electrical installations (also commonly known as 'TPS'); and
- (2) all sizes, configurations and models of 'Polymeric Insulated Electrical Cable' which is PVC sheathed and insulated, round and flexible and is designed for use in low voltage electrical installations (also commonly known as 'Orange Round').

This prohibition expires on 12 October 2014 unless withdrawn earlier.

NOTE: From 12 October 2013 it is an offence for any person or business (including Registered Electrical Contractors and Licensed Electrical Workers) to supply the prohibited electrical equipment specified in this notice. The penalty for disobeying this notice is, in the case of a natural person, 200 penalty units or 2 years imprisonment or both or, in the case of a body corporate, 1000 penalty units.
