## Road Management Act 2004

### ROAD DECLARATIONS AND DISCONTINUATIONS

#### ROAD DECLARATIONS

VicRoads, pursuant to sections 11 and 14 of the **Road Management Act 2004**, upon publication of this notice revokes or declares the roads described in Schedule A and on the plans attached. The effects of these revocations and declarations on road names are described in Table 1.

#### ROAD DISCONTINUATIONS

VicRoads, pursuant to section 12 of the **Road Management Act 2004**, upon publication of this notice discontinues parts of the roads described in Schedule B and on the plans attached subject to the right, power and interest held by City West Water, CitiPower and City of Melbourne over land parcel E-1 described on the plan provided for in section 207C of the **Local Government Act 1989** and approves the sale of the surplus land as provided in section 94 of the **Transport Integration Act 2010** and as delegated by the Minister for Roads under section 31 of the latter said Act.

### SCHEDULE A

#### ARTERIAL ROAD

- a) That part of Docklands Highway identified by hatching on the plan numbered GP22818 is revoked as described in the legend in the said plan.
- b) That part of Portarlington–St Leonards Road identified by hatching on the plan numbered GP22868 is revoked as described in the legend in the said plan.
- c) Those parts of Burnley Road identified by hatching on the plan numbered GP22970 are declared as described in the legend in the said plan.
- d) Those parts of Victoria Street identified by hatching on the plan numbered GP22970 are declared as described in the legend in the said plan.
- e) Those parts of Beach Road identified by hatching on the plan numbered GP305AR are revoked as described in the legend in the said plan.
- f) That part of Fitzroy Street identified by hatching on the plan numbered GP305AR is revoked as described in the legend in the said plan.

#### MUNICIPAL ROAD

- g) That part of Pier Street identified by hatching on the plan numbered GP22868A is declared as described in the legend in the said plan.
- h) That part of Beaconsfield Parade identified by hatching on the plan numbered GP54MU is declared as described in the legend in the said plan.
- i) Those parts of Fitzroy Street identified by hatching on the plan numbered GP54MU are declared as described in the legend in the said plan.

### SCHEDULE B

#### ARTERIAL ROAD

- a) That part of Docklands Highway identified by hatching on the plan numbered GP22818 is discontinued as described in the legend in the said plan.

#### MUNICIPAL ROAD

- b) That part of Grant Street identified by hatching on the plan numbered GP21428 is discontinued as described in the legend in the said plan.

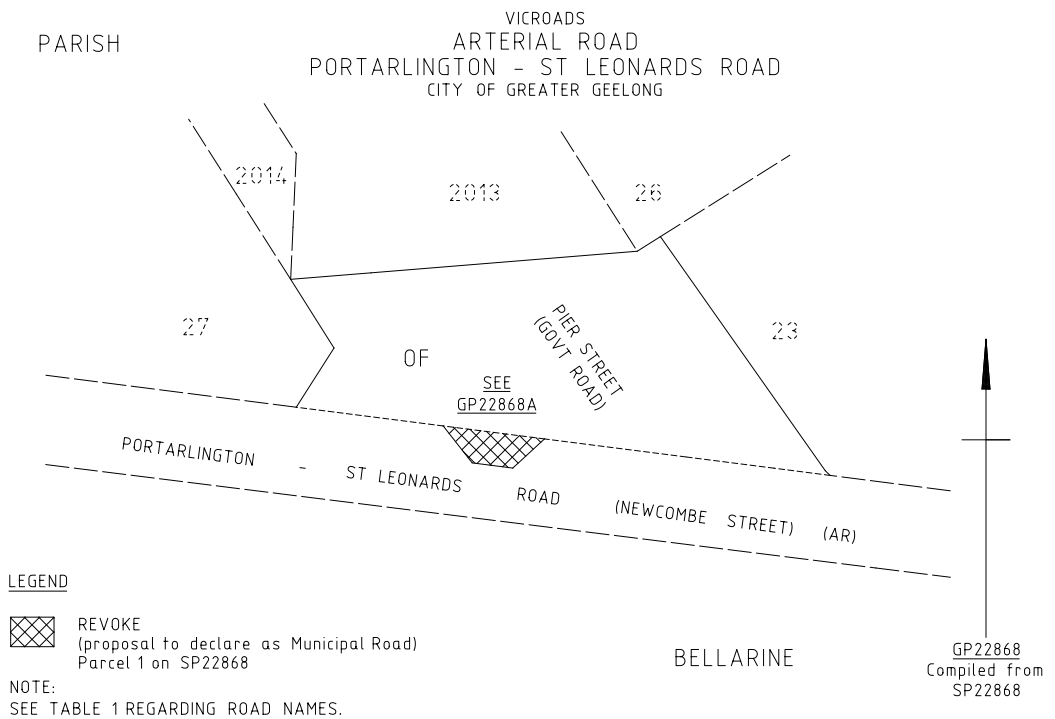
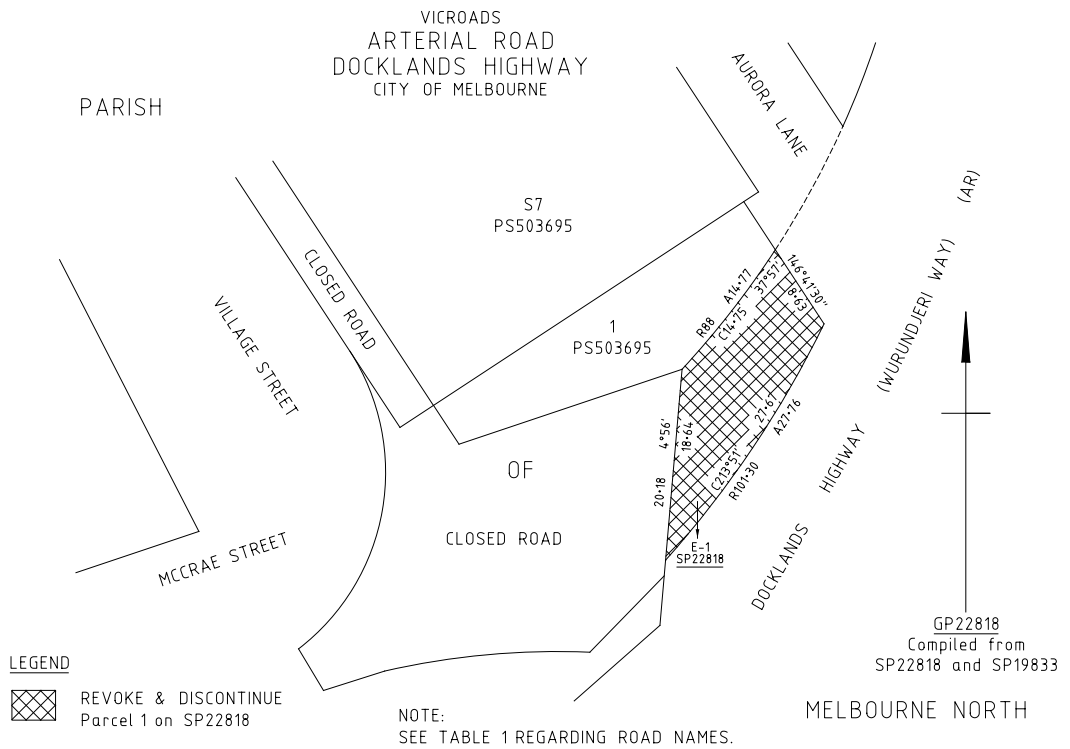

3. Names in Column 2 may not apply to the whole length of the road and are for general information purposes only.

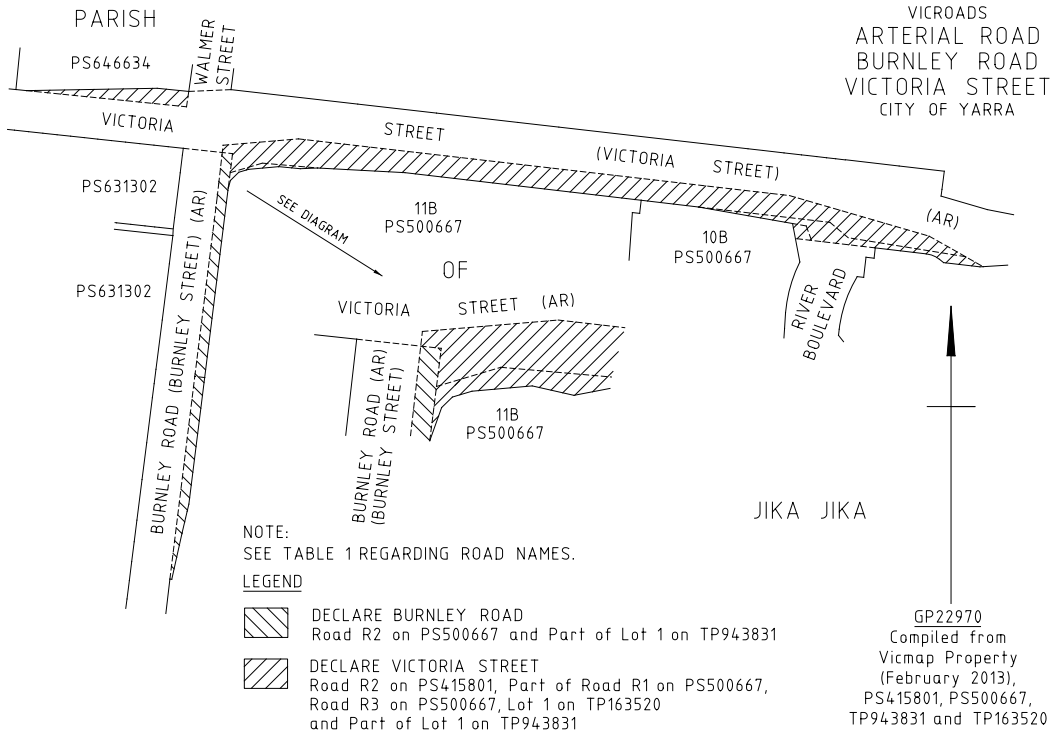
