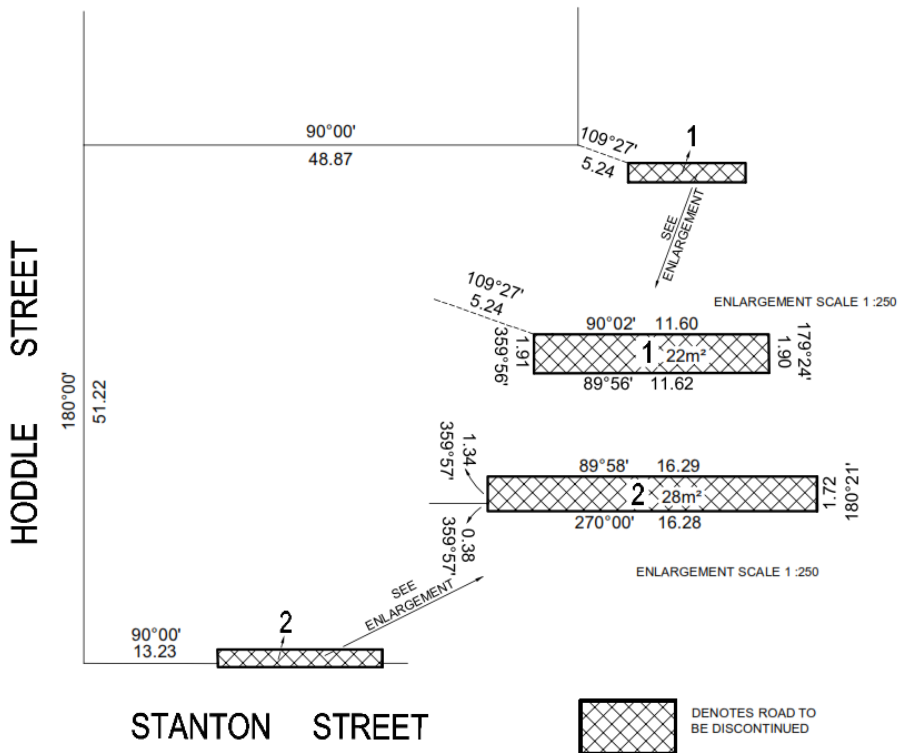

## Notice of Preparation of Amendment

## Amendment C153

## Authorisation A02654

The City of Whittlesea Council has prepared Amendment C153 to the Whittlesea Planning Scheme.

In accordance with section 8A(3) of the **Planning and Environment Act 1987**, the Minister for Planning authorised the City of Whittlesea Council as planning authority to prepare the Amendment.

The Amendment affects land throughout the municipality. There are 148 properties in total that are included in the Amendment.

The Amendment proposes to implement the recommendations of the Whittlesea Heritage Study by applying the Heritage Overlay to sites of local heritage significance, and amends the Heritage Overlay schedule and Planning Scheme maps to correct anomalies and remove redundant controls of existing heritage places.

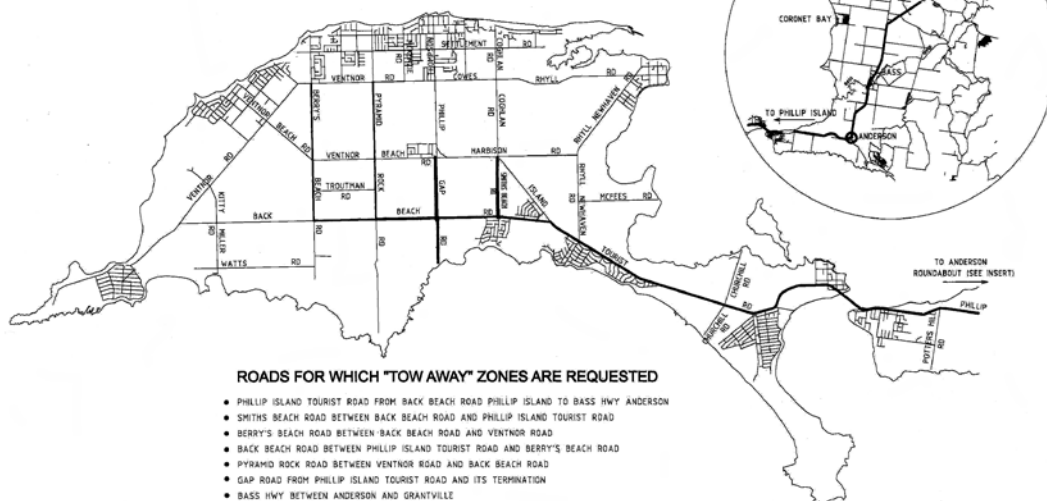

**1. Purpose**

The purpose of this notice is to declare that the certain types of vehicles marked with built date plates indicating their power mass ratios are not probationary prohibited vehicles.

**2. Authorising Provision**
