## Road Safety Act 1986

### DECLARATION OF VARIATION TO RULE 297 OF THE ROAD SAFETY ROAD RULES 2009 UNDER SECTION 96A OF THE ROAD SAFETY ACT 1986

I, Terry Mulder MP, Minister for Roads, being the Minister responsible for administering the **Road Safety Act 1986**, declare under section 96A(1)(b) of that Act that road rule 297 of the Road Safety Road Rules 2009 is varied in the manner set out in this declaration.

#### 1. Commencement

This declaration comes into effect on the date on which it is published in the Victoria Government Gazette.

#### 2. Variation of road rule 297

Road rule 297 of the Road Safety Road Rules 2009 is varied by inserting the following subregulation after road rule 297(4) –

‘(5) Subrule (3) does not apply to Mr Terence O’Grady (also known as ‘Tex O’Grady’) of 41 Bald Hill Road, Macksville, New South Wales 2447, if Mr O’Grady is –

- (a) riding a motor bike to, from, or for the purpose of events or activities conducted for any charitable purpose; and
- (b) carrying a copy of the declaration published in the Victoria Government Gazette that relates to those events or activities, and produces that copy upon request to any member of the police force of Victoria.’

#### 3. Expiry

This declaration expires on the date that is two years after the date of its commencement.
