





PART OF CROWN PORTION 125





Amenity Local Law

Pursuant to section 119 of the **Local Government Act 1989**, the Nillumbik Shire Council, at its 24 September 2013 Ordinary Meeting, resolved to give public notice of its intention to make a new Local Law entitled the Amenity Local Law.

The purpose and general purport of the proposed Local Law is to provide for the:

- a) safe and fair use and enjoyment of public places;
- b) safe and fair use of roads;
- c) regulation of street activities;
- d) keeping and control of animals;
- e) fair and reasonable use and enjoyment of private land;
- f) uniform and fair administration of this Local Law:
- g) peace, order and good government of the municipality; and to
- h) revoke Council's Amendment (Amenity Local Law No. 5) Local Law.

The proposed Local Law may be inspected at the Civic Centre, Civic Drive, Greensborough, during normal office hours and copies may be obtained free of charge. The proposed Local Law may also be viewed at Council's website www.nillumbik.vic.gov.au

In accordance with section 223 of the Local Government Act 1989, written submissions may be made by any person affected by the proposed Local Law. Any person making a submission may request to be heard in support of their submission at a meeting of the Council. Where a person wishes to be heard by Council, they must advise of such in their written submission. Submissions must be received by Council by 4 pm on Thursday 31 October 2013 and should be addressed to the Chief Executive Officer, Nillumbik Shire Council, PO Box 476, Greensborough 3088.

Infrastructure Assets Local Law

Pursuant to section 119 of the **Local Government Act 1989**, the Nillumbik Shire Council, at its 24 September 2013 Ordinary Meeting, resolved to give public notice of its intention to make a new Local Law entitled the Infrastructure Assets Local Law.

The purpose and general purport of the proposed Local Law is to:

- a) provide for the peace, order and good government of the municipal district;
- b) protect public assets vested in Council from damage, accelerated deterioration or abuse during the building works process;
- c) provide a physical environment which aims to minimise hazards to the health and safety of persons attending building sites and those adjacent, opposite or passing building sites;
- d) prohibit, regulate and control the presence and disposal of refuse, rubbish and soil on and from building sites within the municipal district to reduce hazards to the environment and promote an environment where residents can enjoy a quality of life that meets the general expectation of the community;
- e) define the standards to which persons engaged in building works should adhere;
- f) educate and induce persons involved in building works to act responsibly to reduce the extent and cost of infrastructure damage for the benefit of the wider community; and to



This Order is made under section 19 of the Plant Biosecurity Act 2010.

3 Commencement

This Order comes into operation on 1 November 2013, and expires 12 months from that date.

4 Revocation

The Order made under section 9 of the **Plant Health and Plant Products Act 1995** by the Governor in Council on 10 February 2009 declaring areas in Victoria to be control areas for the purpose of preventing the spread of Potato Cyst Nematode as published in Government Gazette G7 on 12 February 2009 is **revoked**.

5 Definitions

Agricultural Equipment means any equipment used for the culture, harvesting, packing or processing of any PCN host plants, including bulk handlers, and any vehicle;

Earth material means soil, gravel, sand or rocks;

Potato Cyst Nematode or 'PCN' means the pest *Globodera rostochiensis* (Wollenweber) Skarbilovich;

Package includes -

- (a) anything in or by which a plant or plant product is contained, wrapped or packed; and
- (b) bulk containers;

PCN host plants means any plant or plant product of the Solanaceae family and any root vegetable, bulb, seedling, nursery plant or tree;

Solanaceae means the family of plants which includes potatoes, tomatoes, eggplants, and weeds including nightshade.

6 Control areas for preventing the spread of Potato Cyst Nematode

The areas described in Schedules 1, 2 and 3 are declared to be control areas for the purpose of preventing the spread of potato cyst nematode.

7 Prohibitions

- (1) The removal from a control area of
 - (a) PCN host plants; or

- (b) any agricultural equipment; or
- (c) any packages, including bins or bulk bags, which have contained any PCN host plants; or
- (d) earth material –

is prohibited.

- (2) Sub-clause (1) does not apply if the plant, equipment, package or earth material is grown on, or sourced from, a property prescribed in Schedule 2 of this Order; and
 - (a) packed, labelled and certified in accordance with any conditions prescribed by an accreditation program administered by the Department of Environment and Primary Industries; or
 - (b) accompanied by a plant health declaration issued by an authorised person declaring that it has been treated in a manner approved by the Director, Plant Biosecurity and Product Integrity or Plant Biosecurity Manager; or
 - (c) accompanied by a plant health certificate issued by an inspector certifying that it has been treated in a manner approved by the Director, Plant Biosecurity and Product Integrity or Plant Biosecurity Manager; or
 - (d) treated, packed or labelled in any other manner approved by the Director, Plant Biosecurity and Product Integrity or Plant Biosecurity Manager.

Note: Section 20(1) of the **Plant Biosecurity Act 2010** provides an offence for a person who causes or permits the movement of any plant, plant product, used package, used equipment or earth material into or from a control area or within a control area or within a specified part of a control area contrary to any prohibition or restriction in an order declaring an area to be a control area if the person knows or may reasonably be expected to know that the place has been declared to be a control area, unless the person is authorised to do so under a permit issued by the Secretary. The maximum penalty for this offence is 60 penalty units in the case of an individual and 300 penalty units in the case of a body corporate. Section 20(3) of the **Plant Biosecurity Act 2010** provides that a person who contravenes any prohibition or restriction in an order declaring a place to be a control area, where that person is not liable for the offence in section 20(1) of the **Plant Biosecurity Act 2010**, is guilty of an offence and is liable to a penalty not exceeding 10 penalty units in the case of an individual and 60 penalty units in the case of a body corporate, unless the person is authorised to do so under a permit issued by the Secretary.






