MELBOURNE CRICKET GROUND FLOODLIGHT DETERMINATION NO. 3/2013

I, Hugh Delahunty, Minister for Sport and Recreation, make the following determination:

1. Title

This determination may be cited as the Melbourne Cricket Ground (Operation of Floodlights) Determination No. 3/2013.

2. Objectives

The objectives of the determination are to:

- (a) Specify the days and times during which the floodlights affixed to the floodlight towers at the Melbourne Cricket Ground (MCG) may be used; and
- (b) Specify the purpose for which the floodlights may be used on those days.

3. Authorising provision

This determination is made under section 30 of the Melbourne Cricket Ground Act 2009.

4. Floodlights may be used on certain days at certain times and for certain purposes

The floodlights affixed to the floodlight towers at the MCG may be used:

- (a) Between 8.00 am and 8.00 pm for the purpose of aligning, testing, repairing and training from 7 October 2013 to 26 March 2014.
- (b) Carols by Candlelight on the 24 December 2013 for the Network Nine telecast between 7.30 pm and 11.00 pm.
- (c) Between 10.00 am 11.00 pm on the following days for the purpose of playing cricket:
 - 27 October 2013 30 October 2013 31 October 2013 1 November 2013 2 November 2013 6 November 2013 7 November 2013 8 November 2013 9 November 2013 29 November 2013 30 November 2013 1 December 2013 2 December 2013 20 December 2013 26 December 2013 27 December 2013 28 December 2013 29 December 2013 30 December 2013 9 January 2014 12 January 2014 21 January 2014
