ROAD MANAGEMENT (GENERAL) REGULATIONS 2005

VicRoads

Proposal to Amend the VicRoads Road Management Plan

In accordance with Regulation 303 of the Road Management (General) Regulations 2005, the Roads Corporation (trading as VicRoads) gives notice that it proposes to amend its Road Management Plan.

The purpose of the proposed amendment, consistent with the role, functions and responsibilities of VicRoads as a responsible road authority under the **Road Management Act 2004**, is to ensure that the standards and priorities that apply to the inspection, maintenance and repair of the roads, roadways, road infrastructure and road-related infrastructure affected by the VicRoads Road Management Plan contribute to the provision of safe and efficient roads for all road users and best meet the needs and priorities of the State and local communities.

The proposed amendment will apply to all freeways, arterial roads and any other roads for which VicRoads is the coordinating road authority as listed in the VicRoads Register of Public Roads.

A copy of the proposed amended VicRoads Road Management Plan may be inspected at, or obtained from, the VicRoads head office at 60 Denmark Street, Kew 3101, or any of its seven regional offices. The amended Plan can also be accessed online at www.vicroads.vic.gov.au by following the link to 'Road Management Act & regulations'.

Any person who is aggrieved by the proposed amendment may make a written submission to VicRoads on the proposed amendment no later than 28 days after the date on which this notice is published.

In reviewing its Road Management Plan, VicRoads has produced a report summarising the findings and conclusions of the review in accordance with Regulation 302(5) of the Road Management (General) Regulations 2005. A copy of this report is also available on the VicRoads webpage.
