- 68/2013 (1) This Part, Divisions 3 and 4 of Part 3 and Part 4 come into operation on the day on which this Act receives the Royal Assent.
 (2) Division 3 of Part 2 is taken to have come into operation on 1 August 2013.
 (3) Subject to subsection (4), the remaining provisions of this Act come into operation on a day or days to be proclaimed.
 (4) If a provision referred to in subsection (3) does not come into operation before 1 October 2014, it comes into operation on that day.
- 69/2013 (1) Parts 1, 4, 5 and 7 and Division 2 of Part 3 of this Act come into operation on the day after the day this Act receives the Royal Assent.
 (2) Part 2 of this Act is taken to have come into operation on 30 January 2001.
 (3) Subject to subsection (4), the remaining provisions of this Act come into operation on a day or days to be proclaimed.
 (4) If a provision of this Act does not come into operation before 1 December 2014, it comes into operation on that day.
- 70/2013 (1) Subject to subsection (2), this Act comes into operation on 1 December 2013.
 (2) The following items in Schedule 1 are taken to have come into operation on the following dates –
 (a) item 10 on 9 May 2012;
 (b) item 24 on 9 February 2013;
 (c) item 35 on 31 January 2013;
 (d) item 47.1 on 30 November 2012;
 (e) item 47.2 on 30 November 2012;
 (f) item 57.2 on 5 February 2012;
 (g) item 59 on 11 February 2013.
- 71/2013 (1) Subject to subsection (2), this Act comes into operation on the day after the day on which it receives the Royal Assent.
 (2) Section 27 is taken to have come into operation on 16 October 2013.
