Crown Land (Reserves) Act 1978

ORDER GIVING APPROVAL TO GRANT OF A LEASE PURSUANT TO SECTIONS 17D AND 17DA

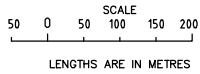
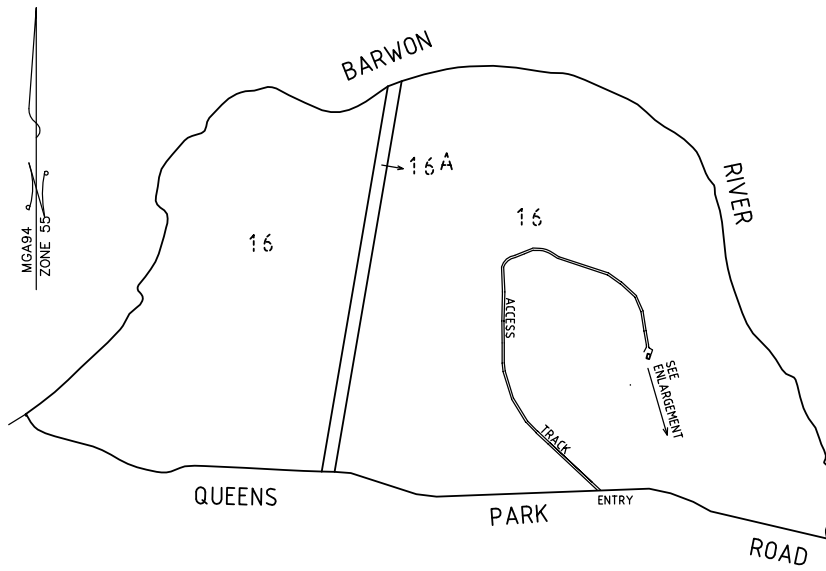
Under sections 17D and 17DA of the **Crown Land (Reserves) Act 1978**, I, Ryan Smith MP, Minister for Environment and Climate Change, being satisfied that there are special reasons which make the granting of a lease reasonable and appropriate in the particular circumstances and to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the **Crown Land (Reserves) Act 1978**, approve the granting of a lease to Telstra Corporation Limited by the Greater Geelong City Council as the Committee of Management, for a term of nine (9) years for the purpose of 'construction, maintenance and operation of a telecommunications facility and telecommunications service' over the area of Crown land being part of Queens Park Reserve described in the Schedule below and, in accordance with section 17D(3)(a) of the **Crown Land (Reserves) Act 1978**, state that –

- (a) there are special reasons which make granting the lease reasonable and appropriate in the particular circumstances; and
- (b) to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the **Crown Land (Reserves) Act 1978**.

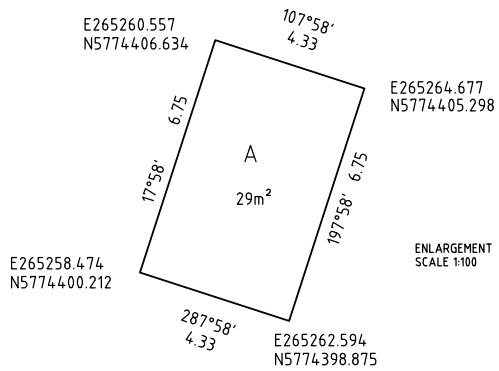
SCHEDULE

The land comprising 29 square metres and defined as area 'A' on the attached plan being portion of Allotment 16, Section 16, Parish of Barrarbool, being Crown land permanently reserved as a site for Public Park and Gardens by Order in Council of 13 April 1965 and by Notice published in the Government Gazette of 23 April 1965, page 1398.
