Gambling Regulation Act 2003

SECTION 4.5.10

Notice is hereby given that the Victorian Commission for Gambling and Liquor Regulation:

- a. Approves, for betting purposes as a class of event under section 4.5.6(1)(a) of the **Gambling Regulation Act 2003** (the Act), the Sport of Volleyball (and Beach Volleyball) controlled and regulated by Volleyball Australia and/or the International Volleyball Federation and contested in the following competitions:
 - i. FIVB World Championships
 - ii. Events sanctioned by FIVB or affiliated international or national organisations eg World League, World Grand Prix, Men's & Womens World Championships, World Cup
 - iii. Beach Volleyball events sanctioned by FIVB or affiliated international or national organisations
 - iv. Olympic Games
 - b. Approves, for the purposes of section 4.5.6(1)(b) of the Act, betting competitions on Volleyball (and Beach Volleyball) events controlled and regulated by Volleyball Australia and/or the International Volleyball Federation and contested in the following tournaments
 - i. FIVB World Championships
 - ii. Events sanctioned by FIVB or affiliated international or national organisations eg World League, World Grand Prix, Men's & Womens World Championships, World Cup
 - iii. Beach Volleyball events sanctioned by FIVB or affiliated international or national organisations
 - iv. Olympic Games
 - c. Specifies, for the purposes of section 4.5.6(2) of the Act, that a betting competition on Volleyball (and Beach Volleyball) is a competition with fixed odds; and
 - d. Determines, for the purposes of section 4.5.9(a) of the Act, that Volleyball (and Beach Volleyball) events, controlled and regulated by Volleyball Australia and/or the International Volleyball Federation and contested in the following tournaments
 - i. FIVB World Championships
 - ii. Events sanctioned by FIVB or affiliated international or national organisations eg World League, World Grand Prix, Men's & Womens World Championships, World Cup
 - iii. Beach Volleyball events sanctioned by FIVB or affiliated international or national organisations
 - iv. Olympic Games
- is a sports betting event for the purposes of Part 5 of the Act.
