### VICTORIA PLANNING PROVISIONS

#### Notice of Approval of Amendment

#### Amendment VC99

The Minister for Planning has approved Amendment VC99 to the Victoria Planning Provisions (VPP) and all planning schemes in Victoria.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment changes the Victoria Planning Provisions and all planning schemes in Victoria by modifying Standards A10, A11 and A13 in Clauses 54.04-1, 54.04-2 and 54.04-4 and Standards B17, B18 and B20 in Clauses 55.04-1, 55.04-2 and 55.04-4 to:

- Increase the distance between a wall and a side or rear boundary threshold from 150 mm to 200 mm for the wall to be considered a wall on boundary.
- Increase the average maximum height of a wall on boundary from 3.0 metres to 3.2 metres.
- Update Diagrams A1 and B1 – Side and rear setbacks and Diagrams A3 and B3 – North-facing windows to include dimensions up to 13.5 metres (four storeys).
