#### Road Safety Act 1986

DECLARATION UNDER SECTION 99B (4) IN RELATION TO NON-ROAD ACTIVITIES ON COMMERCIAL DRIVE, PAKENHAM FOR THE LIONS PROJECT DRIVING FORCE COMMENCING ON 14 DECEMBER 2013

#### 1 Purpose

The purpose of this Declaration is to exempt participants in the Lions Project Driving Force from specified provisions, including section 65A(1), of the **Road Safety Act 1986** and rules under that Act with respect to the Event, which is a non-road activity to be conducted on Commercial Drive, Pakenham, commencing on 14 December 2013.

#### 2 Authorising provision

This notice is made under section 99B(4) of the **Road Safety Act 1986**. Section 99B(4) provides that the Minister may, on the application of a person proposing to conduct a non-road activity on a highway, by notice published in the Government Gazette, declare that specified provisions of the **Road Safety Act 1986** and of the regulations made under that Act do not apply with respect to the non-road activity specified in the notice during the period specified in the notice.

#### 3 Commencement

This notice takes effect at 8.00 am on 14 December 2013.

#### 4 Expiry

This notice expires at 5.00 pm on 18 May 2014.

#### 5 Definitions

In this notice, unless the context or subject-matter otherwise requires -

- a) 'Event' means the Lions Project Driving Force to be held on the Event Dates;
- b) 'Event Area' means the east-west segment of Commercial Drive, Pakenham, west of Export Drive. It does not include any north-south segment of Commercial Drive, or any intersection or nature strips;
- c) 'Event Dates' means the period between 8.00 am and 5.00 pm on the following PRIMARY or ALTERNATIVE DATES for each weekend:

Sunday 18 May 2014	Saturday 17 May 2014

d) 'Participants' means participants in the Event, including officers, members and authorised agents of the Lions Club of Pakenham, whose presence is reasonably required to ensure the safe conduct of the Event.

## SPECIAL

#### 6 Declaration

I, George Mavroyeni, as delegate of the Minister for Roads, under section 99B(4) of the **Road Safety Act 1986** declare that the provisions of the **Road Safety Act 1986** and regulations specified in Table 1 do not apply to Participants engaged in activities forming part of the Event in the Event Area on the Event Dates provided that all safety and other requirements, as determined by the Event organiser, are complied with.
