Order in Council

The Governor in Council under sections 10(1) and 10(2) of the **Cemeteries and Crematoria Act 2003**, appoints the Southern Metropolitan Cemeteries Trust as administrator of the Drouin Public Cemetery. The terms and conditions of the appointment are set out in the attached Schedule.

APPOINTMENT OF AN ADMINISTRATOR TO MANAGE THE DROUIN PUBLIC CEMETERY

Schedule to the Order in Council

1. **Period of appointment**

In accordance with section 10(4) of the **Cemeteries and Crematoria Act 2003**, the appointment is from the date of this Order until:

- (a) the Governor in Council replaces the Administrator with another administrator; or
- (b) the Governor in Council declares that the administration is to end and appoints members to the Drouin Cemetery Trust in accordance with section 6 of the **Cemeteries and Crematoria Act 2003**.

2. **Functions, powers, immunities and duties of the Administrator**

In accordance with section 10(3)(b) of the **Cemeteries and Crematoria Act 2003**, the Administrator acquires all the functions, powers, immunities and duties of the members of the Drouin Cemetery Trust.

The Administrator is required to properly manage and maintain the Drouin Public Cemetery and to carry out any other function conferred on the Drouin Cemetery Trust by the **Cemeteries and Crematoria Act 2003** or any other Act.

3. **Cost recovery**

The Administrator may recover reasonable costs associated with managing the Drouin Public Cemetery.
