#### Road Safety Act 1986

DECLARATION UNDER SECTION 99B(4) IN RELATION TO THE 2013 MOOROOPNA NYE PROCESSION, MOOROOPNA, ON 31 DECEMBER 2013

#### 1 Purpose

The purpose of this Declaration is to exempt participants in the 2013 Mooroopna NYE Procession from specified provisions of the Road Safety Road Rules 2009 with respect to the Event, which is a non-road activity to be conducted on Midland Highway (McLennan Street), Mooroopna, on 31 December 2013.

## 2 Authorising provision

This notice is made under section 99B(4) of the **Road Safety Act 1986**. Section 99B(4) provides that the Minister may, on the application of a person proposing to conduct a non-road activity on a highway, by notice published in the Government Gazette, declare that specified provisions of the **Road Safety Act 1986** and of the regulations made under that Act do not apply with respect to the non-road activity specified in the notice during the period specified in the notice.

#### 3 Commencement

This notice takes effect on 31 December 2013 at 6.30 pm.

## 4 Expiry

This notice expires on 31 December 2013 at 7.30 pm.

#### 5 Definitions

In this notice, unless the context or subject-matter otherwise requires –

- a) 'Event' means the 2013 Mooroopna NYE Procession, to be held on 31 December 2013; and
- b) 'Participants' means participants in the Event, including officers, members and authorised agents of the Rotary Club Mooroopna, whose presence is reasonably required to ensure the safe conduct of the Event.

#### 6 Declaration

I, Peter Todd, Acting Chief Executive, as delegate of the Minister for Roads, under section 99B(4) of the **Road Safety Act 1986** declare that the provisions of the Road Safety Road Rules 2009 specified in Table 1 do not apply to Participants engaged in activities forming part of the Event on the highway specified in column 1 of Table 2, on the date and during the period specified in column 2 of Table 2.
