## **Electricity Safety Act 1998** (Section 141(1))

19 December 2013

### **DIRECTION PURSUANT TO SECTION 141 OF THE ELECTRICITY SAFETY ACT 1998**

Property: 53 TIMBER LANE, KURTING

In accordance with section 141(1) of the **Electricity Safety Act 1998** (the Act), I direct Powercor Australia Ltd (Powercor) to isolate the defective private aerial line (PAL) at 53 Timber Lane, Kurting within 7 days of receipt of this direction.

I am satisfied that the PAL supplying electricity to this property has deteriorated to the extent that it poses an unacceptable risk to the safety of persons, livestock and property, in particular, it has the potential to start a bushfire.

In certain circumstances Powercor may be able to apply to the Victorian Civil and Administrative Tribunal (VCAT) for a review of this direction pursuant to section 69(3) of the Act. An application for review under this section of the Act must be made within seven (7) days of receiving this direction.

Significant penalties apply for a failure to comply with this direction.
