ORDER MADE UNDER SECTION 143A OF THE
TRANSPORT (COMPLIANCE AND MISCELLANEOUS) ACT 1983
for the granting of taxi-cab licences in taxi-cab zones

Definitions

In this Order:

Bendigo Urban Taxi-cab Zone means the area described as such in Schedule 1 to this Order;

Bendigo Urban WAT Licence means a taxi-cab licence granted under this Order;

Order means this Order of the Minister made under section 143A(1) of the **Transport (Compliance and Miscellaneous) Act 1983**, published in the Victoria Government Gazette;

Transport Act means the **Transport (Compliance and Miscellaneous) Act 1983**;

WAT means a wheelchair accessible taxi-cab, which is a taxi-cab specifically constructed or modified for the carriage of at least one person seated in a wheelchair.

Order

I, the Hon. Terry Mulder MP, Minister for Public Transport and Minister for Roads, by Order under section 143A of the **Transport (Compliance and Miscellaneous) Act 1983**:

Proclaimed taxi-cab zones

1. proclaim the Bendigo Urban Taxi-cab Zone as a proclaimed taxi-cab zone for the purpose of granting a Bendigo Urban WAT Licence in accordance with this Order;

Fee to be paid for taxi-cab licence

2. specify that the fee to be paid for a Bendigo Urban WAT Licence is to be a fixed price;
3. specify that the fixed price to be paid for a Bendigo Urban WAT Licence is \$18,400;

Characteristics of taxi-cab licence

4. specify that only one Bendigo Urban WAT Licence may be granted under this Order;
5. specify that a Bendigo Urban WAT Licence may be granted for a fixed term of one year only. This term will commence on the date a Bendigo Urban WAT Licence is granted by the licensing authority;
6. specify that a Bendigo Urban WAT Licence will be subject to a condition that it cannot be assigned;
7. specify that a Bendigo Urban WAT Licence is transferable;

Note: The information in paragraphs 6 and 7 is stated for the purpose of sections 143D(2) of the Transport Act. The non-assignment and non-transferable conditions will be imposed by the licensing authority under section 143D of the Transport Act.

Classes and qualifications of persons eligible to apply

8. specify that the Bendigo Urban WAT Licence granted under this Order are to the applicant whose application was approved by the Minister for Public Transport on or around 2 September 2012.

3. specify that the fixed price to be paid for a Pakenham Taxi-cab Licence is \$3400;

Characteristics of taxi-cab licence

4. specify that only two Pakenham Taxi-cab Licences may be granted under this Order;
5. specify that the Pakenham Taxi-cab Licences may be granted for a fixed term of one year only. This term will commence on the date the Pakenham Taxi-cab Licences are granted by the licensing authority;
6. specify that each Pakenham Taxi-cab Licence will be subject to a condition that it cannot be assigned;
7. specify that each Pakenham Taxi-cab Licence will be transferable;

Port Phillip Taxi-Cab Zone means the area described as such in Schedule 1 to this Order;

Port Phillip WAT Licence means a WAT licence granted under this Order at a fixed price, and to which is attached (or intended to be attached) a condition that the taxi-cab licenced to operate under the licence is a wheelchair accessible taxi-cab, other than a Port Phillip Conventional Taxi-cab Licence;

Transport Act means the **Transport (Compliance and Miscellaneous) Act 1983**;

WAT means a wheelchair accessible taxi-cab, which is a taxi-cab specifically constructed or modified for the carriage of at least one person seated in a wheelchair.

Order

I, the Hon. Terry Mulder MP, Minister for Public Transport and Minister for Roads, by Order under section 143A of the **Transport (Compliance and Miscellaneous) Act 1983**:

Proclaimed taxi-cab zones

1. proclaim the Port Phillip Taxi-cab Zone as a proclaimed taxi-cab zone for the purpose of granting two Port Phillip Conventional Taxi-cab Licences and one Port Phillip WAT Licence in accordance with this Order;

Fee to be paid for taxi-cab licence

2. specify that the fee to be paid for a Port Phillip Conventional Taxi-cab Licence and a Port Phillip WAT Licence is to be a fixed price;
3. specify that the fixed price to be paid for a Port Phillip Conventional Taxi-cab Licence is \$3400;
4. specify that the fixed price to be paid for a Port Phillip WAT Licence is \$3400;

Characteristics of taxi-cab licence

5. specify that only two Port Phillip Conventional Taxi-cab Licences and one Port Phillip WAT Licence may be granted under this Order;
6. specify that the Port Phillip Conventional Taxi-cab Licences and the Port Phillip WAT Licence may be granted for a fixed term of one year only. This term will commence on the date the Port Phillip Conventional Taxi-cab Licences and the Port Phillip WAT Licence are granted by the licensing authority;
7. specify that each Port Phillip Conventional Taxi-cab Licences and Port Phillip WAT Licence will be subject to a condition that it cannot be assigned;
8. specify that each Port Phillip Conventional Taxi-cab Licences and Port Phillip WAT Licence is transferable;

Note: The information in paragraphs 7 and 8 is stated for the purpose of sections 143D(2) of the Transport Act. The non-assignment and non-transferable conditions will be imposed by the licensing authority under section 143D of the Transport Act.

Classes and qualifications of persons eligible to apply

9. specify that the person or entity that may apply must have provided the licensing authority with a submission outlining an interest in being granted a licence in the area comprising the Port Phillip Taxi-cab Zone within nine months prior to the date of this Order.

The Port Phillip Taxi-cab Zone is the area bounded by the coastline, Canadian Bay Road, Mt Eliza Way, Wooralla Drive, Moorooduc Road, Eramosa Road, Derril Road, Balnarring Road, Tubbarubba Road, Bittern–Dromana Road, Red Hill Road, Station Road, Red Hill–Shoreham Road, Shands Road, Mornington–Flinders Road, Meakin Road, Boneo Road, Cape Shank Road, and the coastline to Canadian Bay Road.

5. specify that the Sunbury Interchangeable WAT Licences may be granted for a fixed term of one year only. This term will commence on the date the Sunbury Interchangeable WAT Licences are granted by the licensing authority;
6. specify that each Sunbury Interchangeable WAT Licence will be subject to a condition that it cannot be assigned;
7. specify that each Sunbury Interchangeable WAT Licence will be transferable;

8. specify that the Sunbury Interchangeable WAT Licences granted under this Order are to the person or entity whose submission was approved by the Minister for Public Transport on or around 2 September 2012.
