## **Electricity Safety Act 1998**

AMENDMENT OF ORDER IN COUNCIL EXEMPTING ELECTRICAL WORK UNDER SECTION 4

Order in Council

The Lieutenant-Governor, as the Governor's Deputy, with the advice of the Executive Council, under section 4(1)(c) of the **Electricity Safety Act 1998**, amends the Order in Council that was made on 28 April 1999, published in the Government Gazette on 29 April 1999 (G17) at page 999, and subsequently amended by Orders in Council published in the Government Gazette on 16 December 1999 (G50), 27 January 2000 (G4), 7 September 2000 (G36), 24 October 2002 (G43), 16 December 2004 (G51), 19 October 2006 (G42), and 13 August 2009 (G33) (the Principal Order).

In the Principal Order, paragraph (e) of Part 3 is substituted -

- (e) involving the installation, maintenance or removal of surveillance devices or enhancement equipment within the meaning of the **Surveillance Devices Act 1999** where that installation, maintenance or removal is carried out –
  - (i) by a person who
    - (A) is authorised in writing by the Commissioner within the meaning of section 3 of the **Independent Broad-based Anti-corruption Commission Act 2011**; and
    - (B) has satisfactorily completed a training course approved by Energy Safe Victoria; and
  - (ii) in conjunction with a warrant granted under the Surveillance Devices Act 1999.'

This Order in Council takes effect on the same day that section 16 of the Independent Broad-based Anti-corruption Commission Amendment (Investigative Functions) Act 2012 commences operation.
