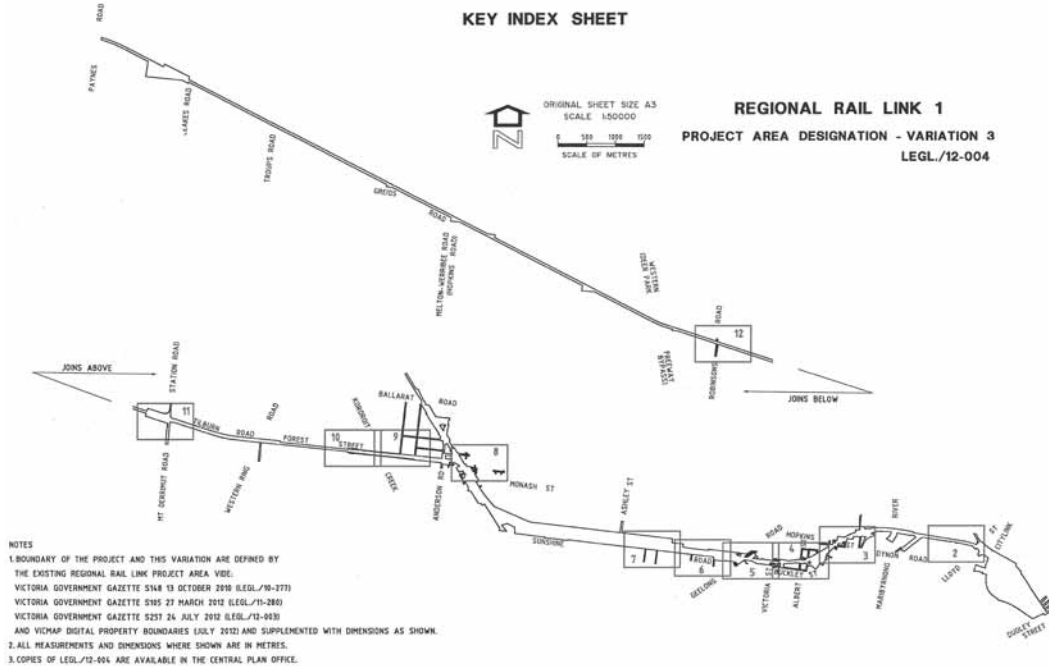
### VARIATION OF THE PROJECT AREA FOR THE APPROVED PROJECT REGIONAL RAIL LINK SECTION 1

#### Order

I, Matthew Guy, Minister for Planning, make the following Order pursuant to section 96(3)(a) of the **Major Transport Projects Facilitation Act 2009** (the Act):

The project area (as shown on the plans with reference LEGL./11-280 (Sheets 1 to 39 inclusive) signed by the Surveyor-General and lodged at the Central Plan Office on 12 January 2012 and as shown on the plans with reference LEGL./12-003 (Sheets 1 to 7 inclusive) signed by the Surveyor-General and lodged at the Central Plan Office on 8 June 2012) for the Regional Rail Link 1 project (declared by the Governor in Council to be a declared project pursuant to section 10(1)(b) of the Act and published in the Government Gazette on 6 July 2010) is varied by increasing the project area by designating an area of land in the vicinity of the project area to be part of the project area as shown on the plans with reference LEGL./12-004 (Sheets 1 to 12 inclusive) signed by the Surveyor-General and lodged at the Central Plan Office on 18 January 2013, and as generally indicated on the map in the Schedule.
